Lender is a organized and existing under the laws of the United States of America Lender's address is 707 Ridge Road, Munster, IN 46321

Lender is the mortgagee under this Security Instrument.

(D) "Note" means the promissory note signed by Borrower and dated October 2, 2003

The Note states that Borrower owes Lender One Hundred Twelve Thousand Nine Hundred and no/100 U.S. \$112,900.00 plus interest. Borrower has promised to pay this debt in regular Periodic Payments and to pay the debt in full not later than November 1, 2033

(E) "Property" means the property that is described below under the heading "Transfer of Rights in the Property."

(F) "Loan" means the debt evidenced by the Note, plus interest, any prepayment charges and late charges due under the Note, and all sums due under this Security Instrument, plus interest.

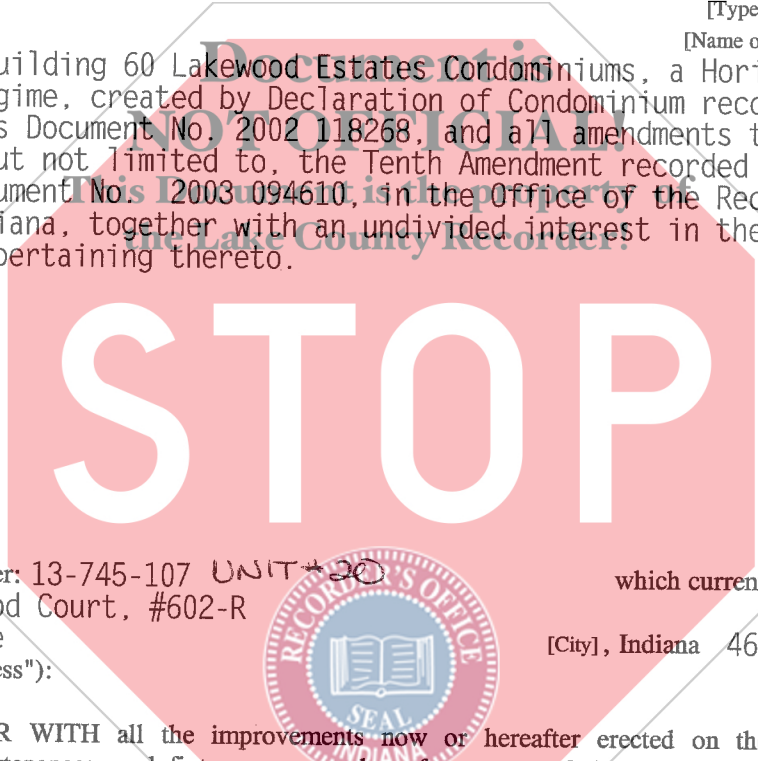

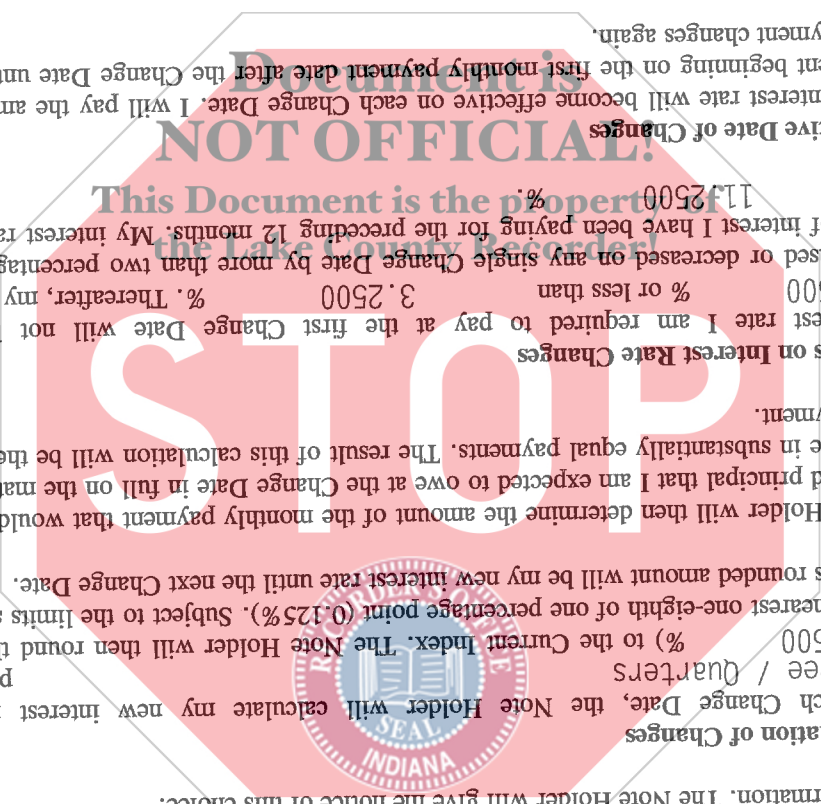
(E) Effective Date of Changes



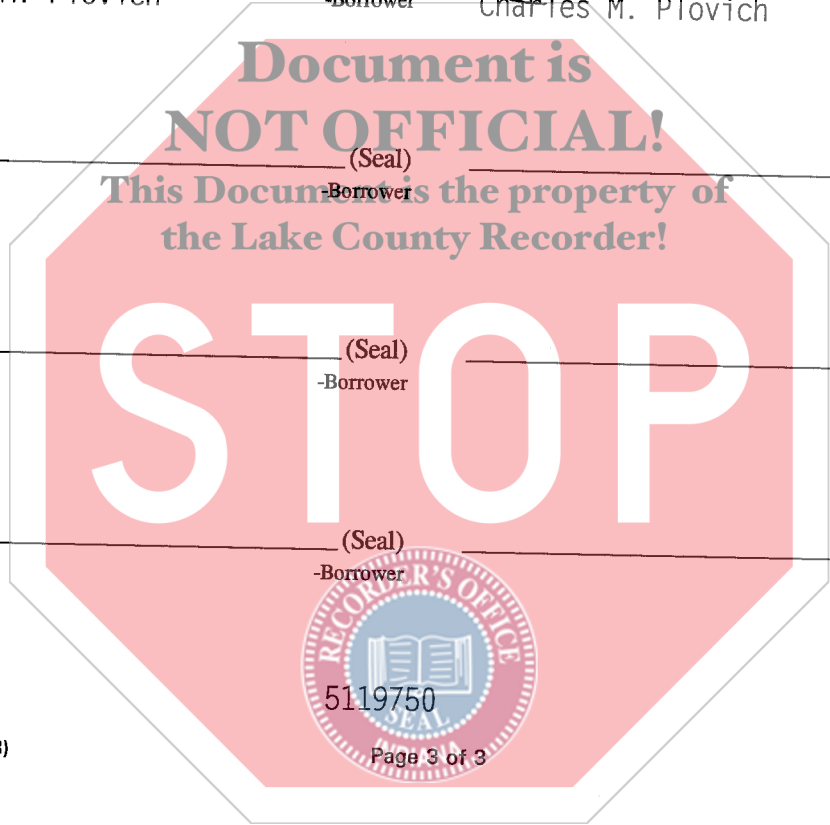
