That affiant is the owner in fee simple of the following described real estate located in Lake County, Indiana, more particularly described as follows: That portion of Lot 8, as marked and laid down on the recorded plat of Woods Park, Unit No. 2, a subdivision in Lake County, Indiana, described as follows: Beginning at a point on the North line of said Lot 8, which point is 40 feet westerly of the Northeast corner of said Lot; thence in an easterly direction along said North line to the Northeast corner a distance of 40 feet; thence southerly along the east line of said Lot 8, to the southeast corner of said lot; thence westerly along the South line of said lot, a distance of 47 1/2 feet; thence northerly to the point of beginning, recorded in Plat Book 735, Page 136 recorded in the Office of the Recorder of Lake County, Indiana, commonly known as 2119 W. 50th Place, Gary, Indiana, 46408.

That the decedent Pasquale J. Amico and the affiant acquired title as joint tenants with right of survivorship to said real estate by deed of conveyance on the October 23, 1964, and recorded in the Office of the Lake County Recorder.

That the decedent and the affiant jointly held title to said real estate until the death of Pasquale J. Amico on March 31, 2002, at which time this affiant acquired title to the real estate as the surviving joint tenant pursuant to property law.

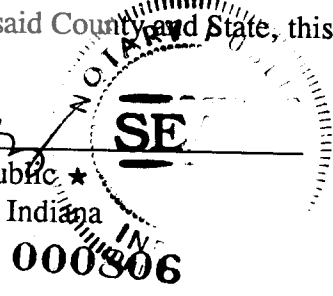
