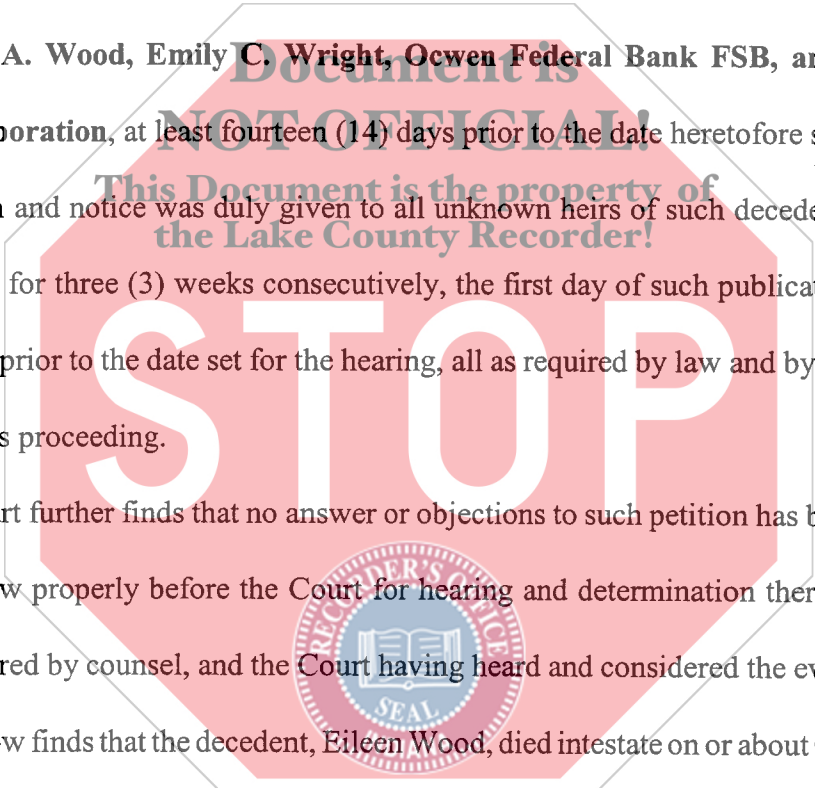

And the Court examined said petition and being duly advised in the premises now finds that notice was duly given and served by the Clerk of the Court of the following persons: **Ronald D. Wood, Keith A. Wood, Emily C. Wright, Ocwen Federal Bank FSB, and New Century Mortgage Corporation**, at least fourteen (14) days prior to the date heretofore set for the hearing on such petition and notice was duly given to all unknown heirs of such decedent by publication once each week for three (3) weeks consecutively, the first day of such publication being at least thirty (30) days prior to the date set for the hearing, all as required by law and by the prior order of this Court in this proceeding.
