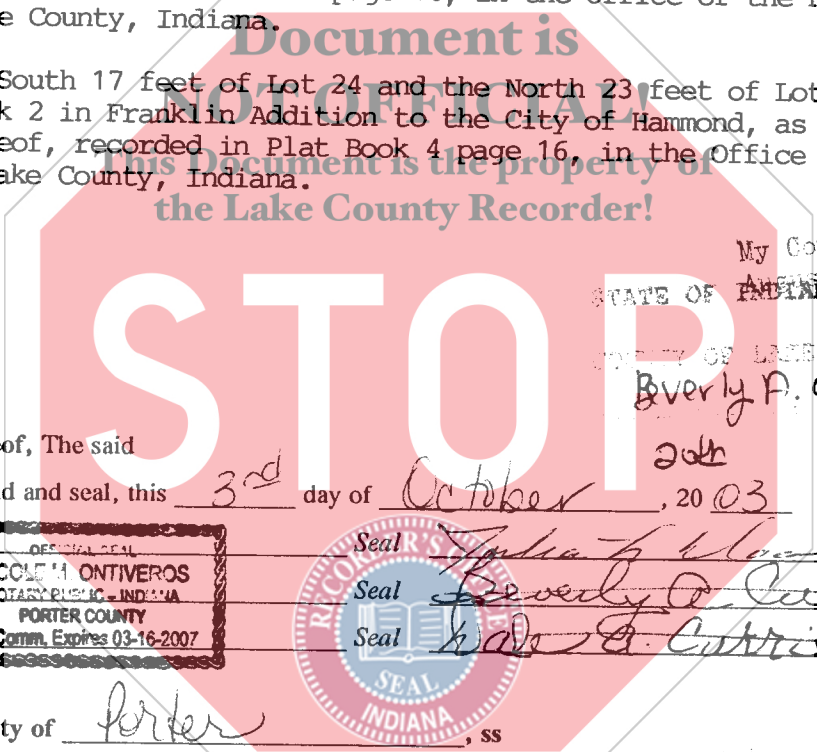

of Lake County, Indiana.

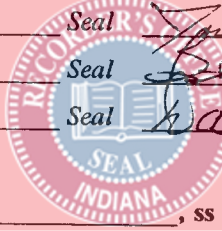
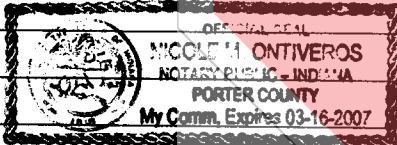
