1. That she is the wife of Walter F. Swieton that they were married on the date that they acquired a contract interest dated 10-11-01, recorded 10-18-01 as Document No. 2001-84340 to certain Real Estate in Lake County, Indiana To- Wit:

Parcel 1: Lot 7, (except the North 8 feet thereof) and all of Lot 8 in Parrish Park Seventh Addition, to the City of Hammond, as per plat thereof, recorded in Plat Book 49, page 113, in the Office of the Recorder of Lake County, Indiana.

Parcel 2: The West 135 feet of Lot "A", Block 3, in Resubdivision of Sunshine Addition to Hammond, as per plat thereof recorded in Plat Book 28, page 31, in the Office of the Recorder of Lake County, Indiana.

2. The marital relationship which existed between Linda J. Swieton and Walter F. Swieton continued unbroken from the time they so acquired a contract interest to said real estate until the death of Walter F. Swieton on December 26, 2002.
