LIMITED POWER OF ATTORNEY

WM Specialty Mortgage LLC, a Delaware limited liability company, having an office at 23861 El Toro Road, Lake Forest, California 92630, hereby constitutes and appoints Countrywide Home Loans, Inc. as its true and lawful attorney-in-fact, and in its name, place and stead and for its use and benefit, to execute and acknowledge in writing or by facsimile stamp all documents customarily and reasonably necessary and appropriate for the tasks described in items (1) through (4) below, provided however, that the documents are required or permitted under the terms of the related servicing and/or subservicing agreements and no power is granted hereunder to take any action that would be adverse to the interests of the Holders. This Limited Power of Attorney is being issued in connection with Countrywide's responsibilities to service certain mortgage loans (the "Loans") under the Servicing Agreement dated July 17, 2000. The Loans are comprised of Mortgages, Deeds of Trust, Deeds to Secure Debt and other forms of Security Instruments (collectively the "Security Instruments") and the Notes secured thereby.

1. Demand, sue for, recover, collect and receive each and every sum of money, debt, account and interest (which now is, or hereafter shall become due and payable) belonging to or claimed by WM Specialty Mortgage LLC, and to use or take any lawful means for recovery by legal process or otherwise.
2. Transact business of any kind regarding the Loans, and obtain an interest therein and/or buildings thereon, as a Countrywide Home Loans act and deed, to contract for, purchase, receive and take possession and evidence of title in and to the property and/or secure payment of a promissory note or performance of any obligation or agreement.
3. Execute bonds, notes, mortgages, deeds of trust and other contracts, agreements (including subordination agreements and modification agreements) and instruments regarding the Borrowers and/or Property, including but not limited to the execution of releases, satisfactions, assignments, and other instruments pertaining to mortgages or deeds of trust, and execution of deeds and associated instruments, if any, conveying the Property, in the interest of WM Specialty Mortgage LLC.
4. Endorse on behalf of the undersigned all checks, drafts and/or other negotiable instrument made payable to the undersigned.
