THIS INDENTURE WITNESSETH, That Catherine Maureen Brown

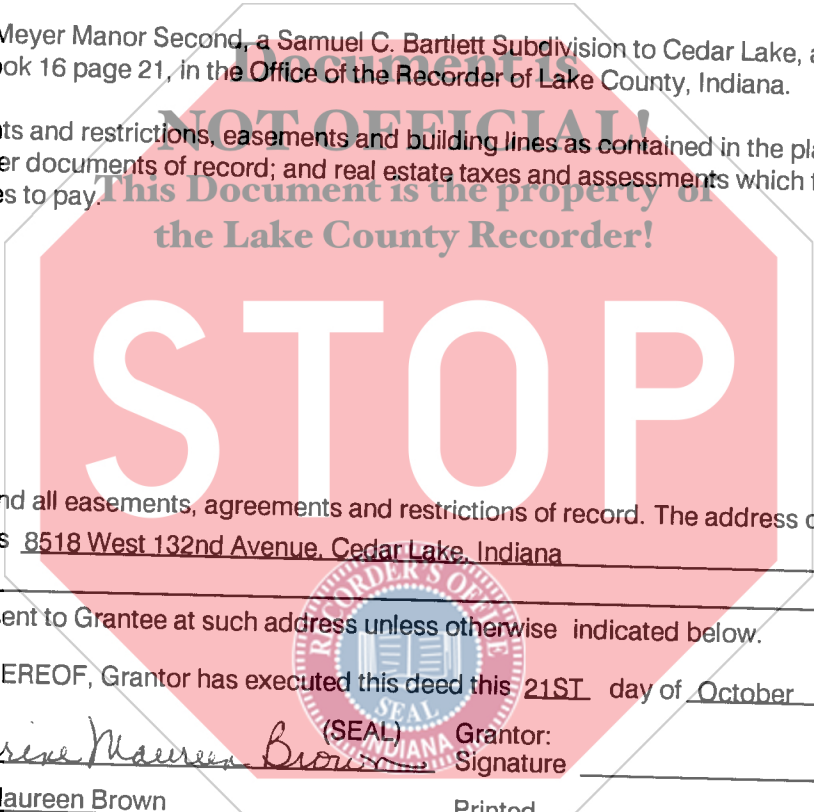
