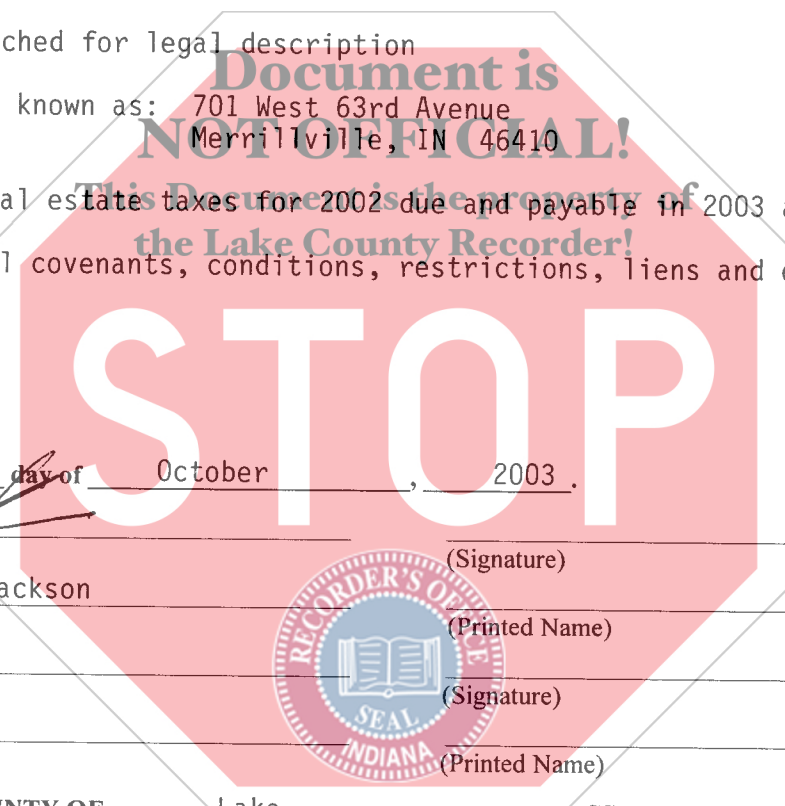

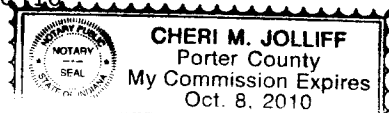

LEGAL DESCRIPTION
