- 3.2 <u>Contribution Agreement</u>. Nothing herein shall modify the obligations of Assignors and Assignee as set forth in the Contribution Agreement. The Contribution Agreement shall not be merged into this Assignment and shall continue in full force and effect in accordance with its terms. The representations, warranties, covenants and limitations contained in the Contribution Agreement and affecting the Right of Way Interests shall apply with equal effect under this Assignment, it being understood that "Contributors" in the Contribution Agreement are "Assignors" herein and "Contributee" in the Contribution Agreement shall be deemed to be "Assignee" herein. In the event of any conflict between this Assignment and the Contribution Agreement, the terms and conditions of the Contribution Agreement shall govern.
- Assumption. Assignee expressly assumes and shall timely perform and 3.3 discharge all duties and obligations of the owner of the Right of Way Interests that are attributable to the period of time on and after the Effective Time. Assignors shall retain and be responsible for all liabilities and obligations relating to the Right of Way Interests that are attributable to the period of time prior to the Effective Time, unless same arise out of or fall under Assumed Liabilities, as such term is defined in the Contribution Agreement, in which case such liabilities and obligations shall be assumed by Assignee. In consideration of this Assignment, Assignee hereby accepts the same and assumes and agrees to make any and all payments required under the Right of Way Interests from and after the Effective Time, and to observe and perform all of the covenants, agreements and conditions contained therein on the part of the Assignors to be observed and performed from and after the Effective Time and further covenants to exonerate, save harmless, protect and indemnify the Assignors, their parents, subsidiaries and affiliates, and their respective directors, officers, partners, employees, contractors, agents, representatives, successors and assigns, from and against any and all losses, liabilities, penalties, damages, claims, demands, suits or actions, judgments and costs and expenses in any manner arising out of, or relating to, the Right of Way Interests from and after the Effective Time, unless same arise out of or fall under Assumed Liabilities, as such term is defined in the Contribution Agreement, in which case such liabilities and obligations shall be assumed by Assignee.
- 3.4 <u>Successors and Assigns</u>. This Assignment shall bind and inure to the benefit of Assignors and Assignee and their respective successors and assigns.
