

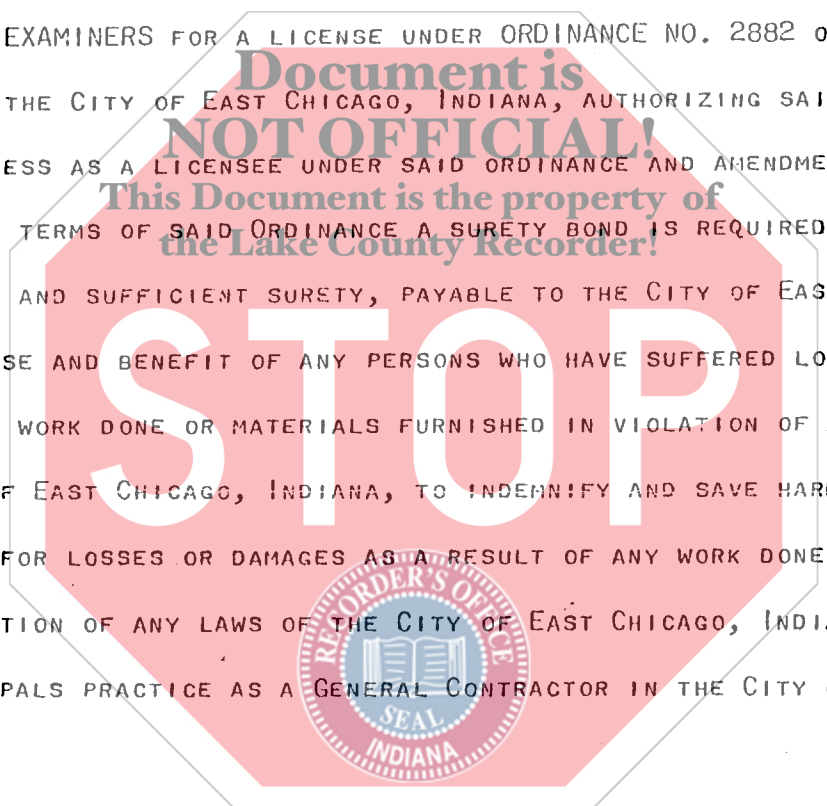
(2) KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, THE ABOVE BOUNDEN PRINCIPAL HAS MADE APPLICATION TO THE BUILDING CONTRACTORS BOARD OF EXAMINERS FOR A LICENSE UNDER ORDINANCE NO. 2882 OF THE MUNICIPAL CODE OF THE CITY OF EAST CHICAGO, INDIANA, AUTHORIZING SAID PRINCIPAL TO ENGAGE IN BUSINESS AS A LICENSEE UNDER SAID ORDINANCE AND AMENDMENTS THERETO AND WHEREAS, UNDER THE TERMS OF SAID ORDINANCE A SURETY BOND IS REQUIRED OF SAID PRINCIPAL AND GOOD AND SUFFICIENT SURETY, PAYABLE TO THE CITY OF EAST CHICAGO, INDIANA, FOR THE USE AND BENEFIT OF ANY PERSONS WHO HAVE SUFFERED LOSS OR DAMAGES AS A RESULT OF ANY WORK DONE OR MATERIALS FURNISHED IN VIOLATION OF ANY OF THE LAWS OF THE CITY OF EAST CHICAGO, INDIANA, TO INDEMNIFY AND SAVE HARMLESS THE AFORESAID PERSONS FOR LOSSES OR DAMAGES AS A RESULT OF ANY WORK DONE OR MATERIALS FURNISHED IN VIOLATION OF ANY LAWS OF THE CITY OF EAST CHICAGO, INDIANA, ARISING OUT OF SAID PRINCIPALS PRACTICE AS A GENERAL CONTRACTOR IN THE CITY OF EAST CHICAGO, INDIANA.
