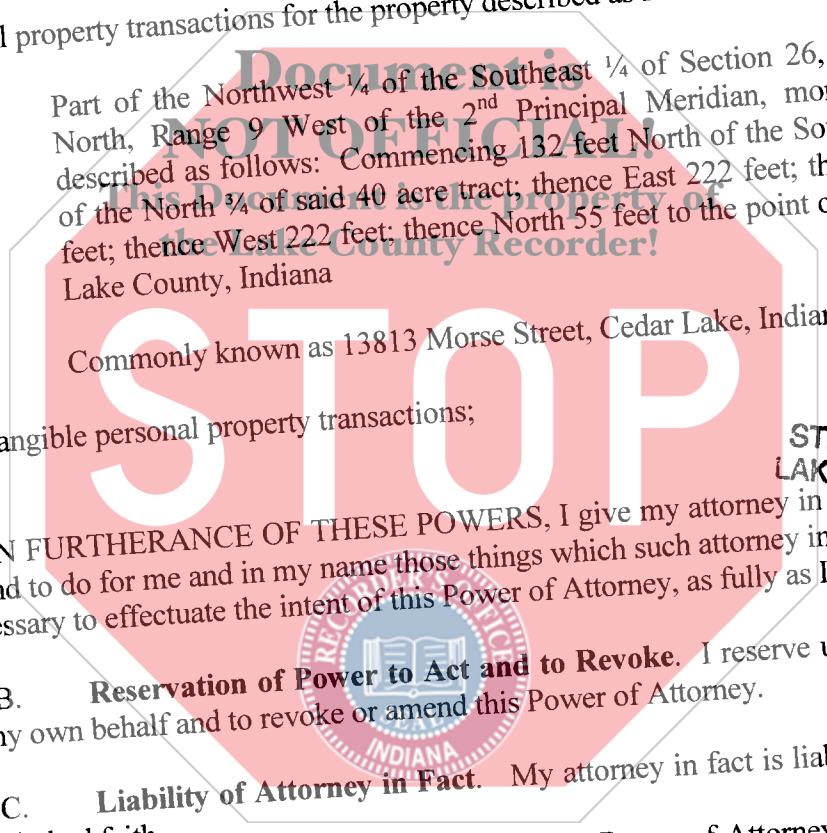
B. **Reservation of Power to Act and to Revoke.** I reserve unto myself the power to act on my own behalf and to revoke or amend this Power of Attorney.
