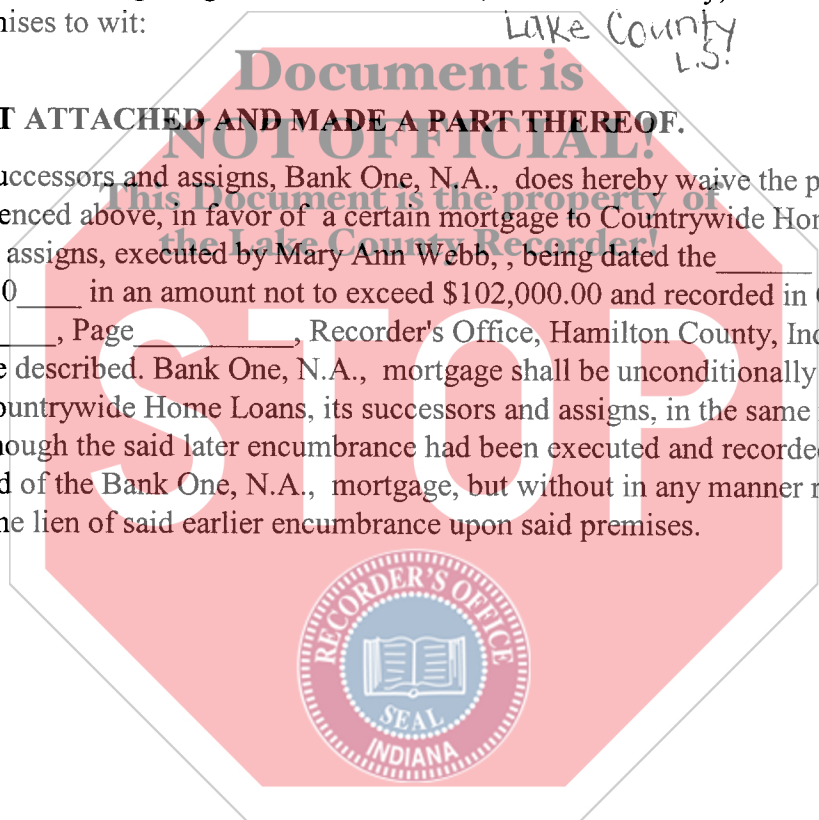
SUBORDINATION OF MORTGAGE
