Contents of the Special Power of Attorney from clause: 1 to 3 are hereby re-confirmed under oath as of this date of execution of this legal document.

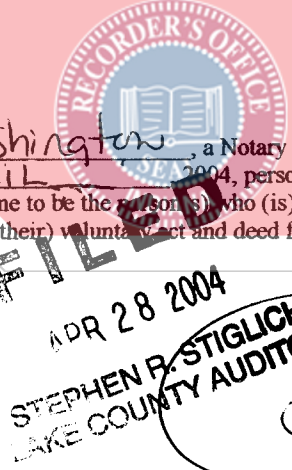
