is hereby vested in EVA MALDARESCU, as devisee under the Last Will and Testament of said decedent.

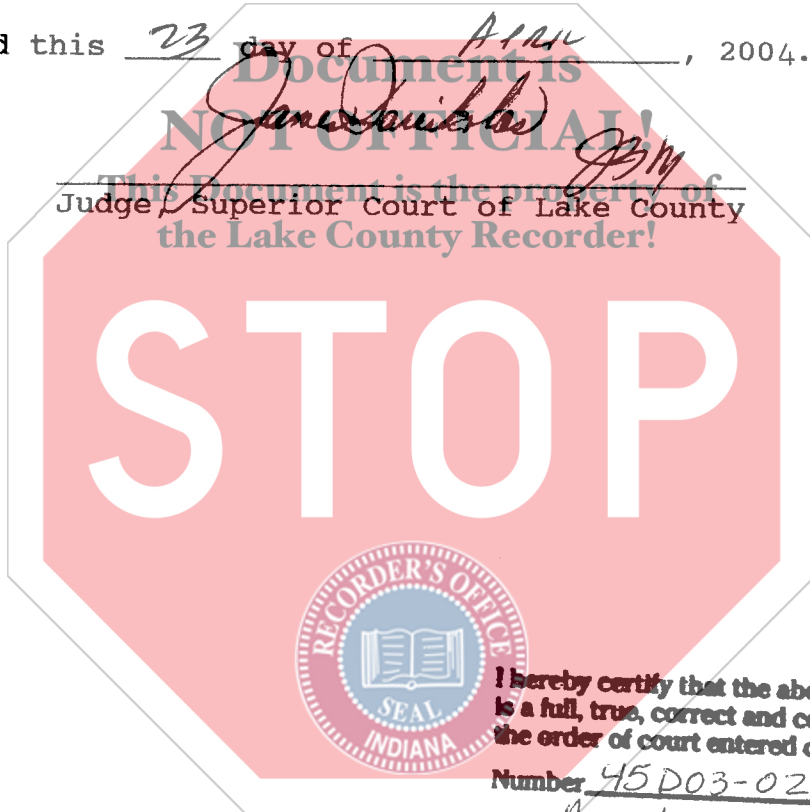
Said Executrix is hereby directed to procure and to record a certified copy of the final decree in the Office of the County Recorder in the county in which such real estate is located.
