Commonly Known as 9609 Crestwood Avenue, Munster, Indiana 46321

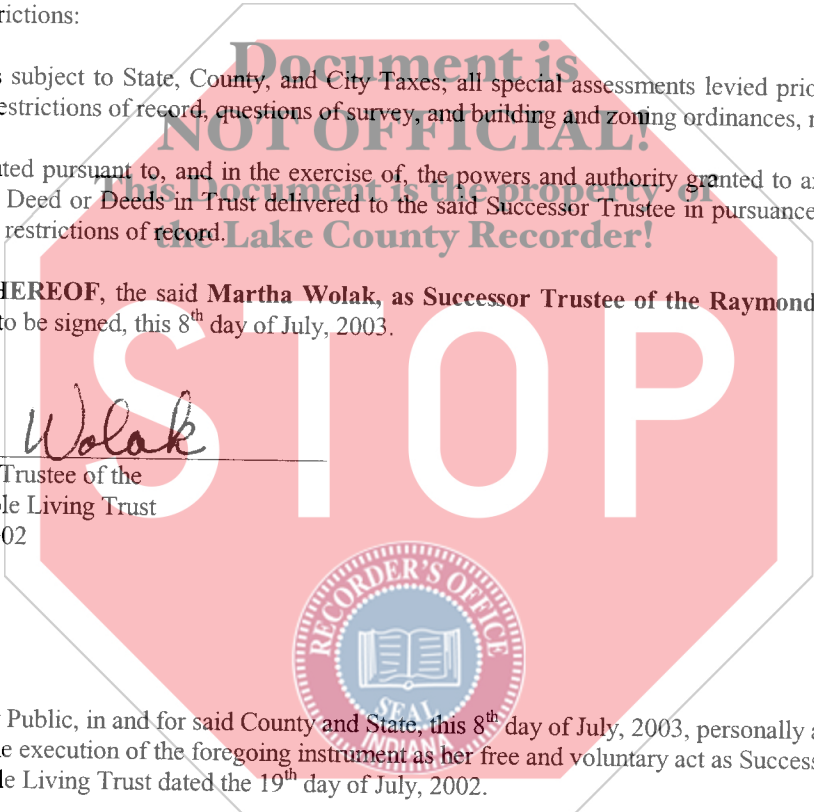
