1. All acts, as specified in Paragraphs 2 and 3 below, relating to the closing of the sale of certain real estate to Lucina Martinez, which real estate is described as:

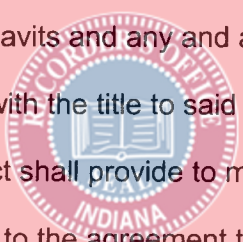
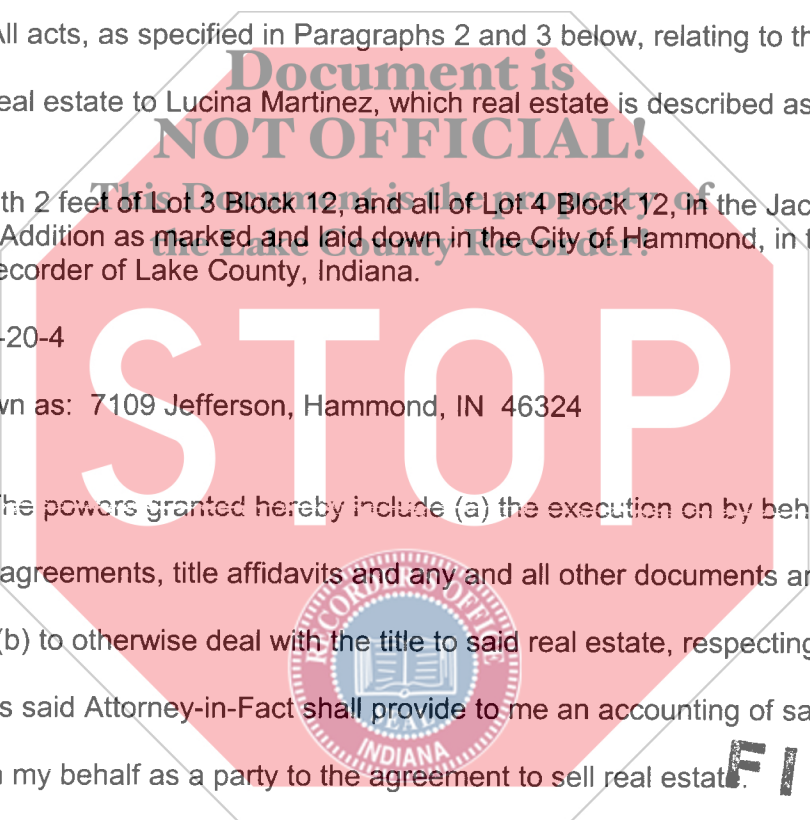
