Grant, bargain, or sell the real property presently owned by **Troy D. Raco**, in Lake County, Indiana, that is legally described as follows:

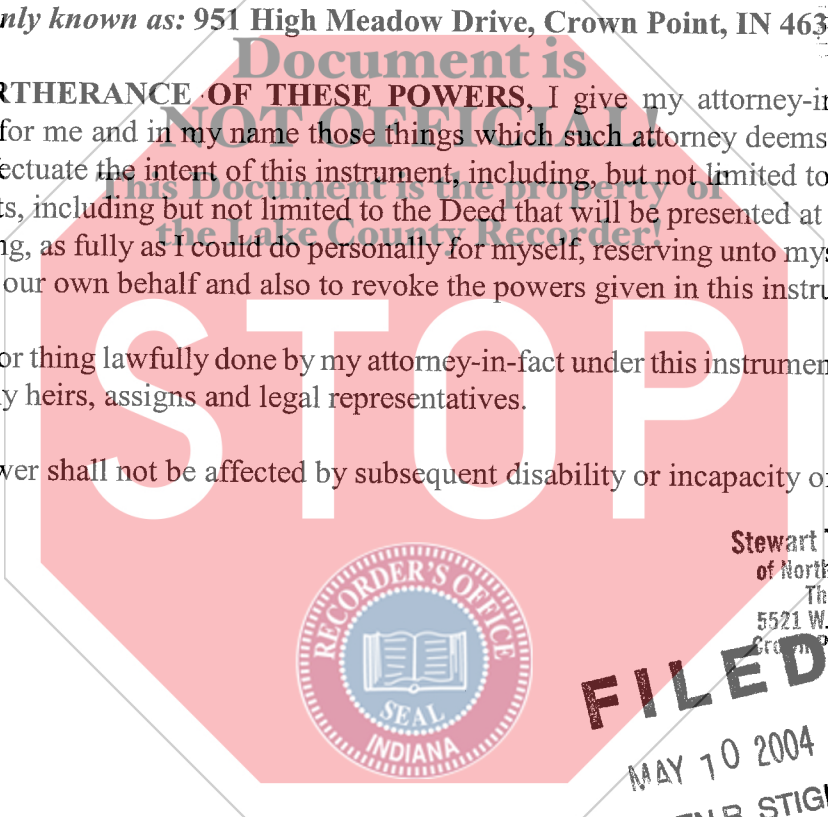



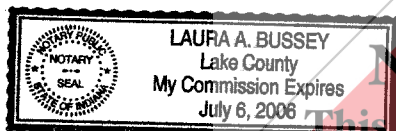
