hereon.

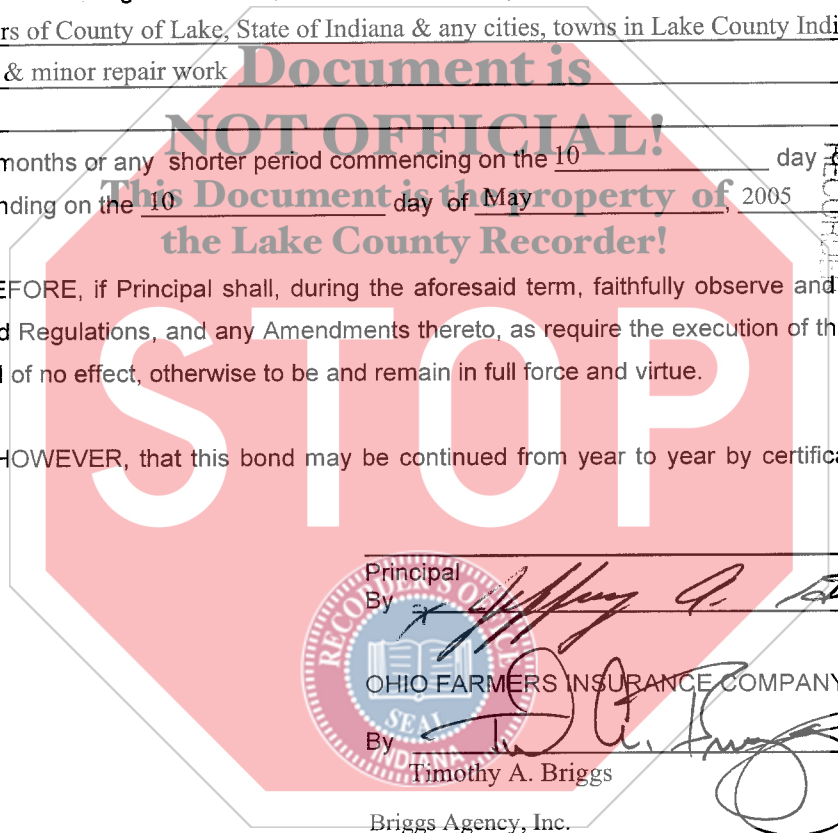

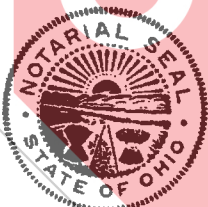
