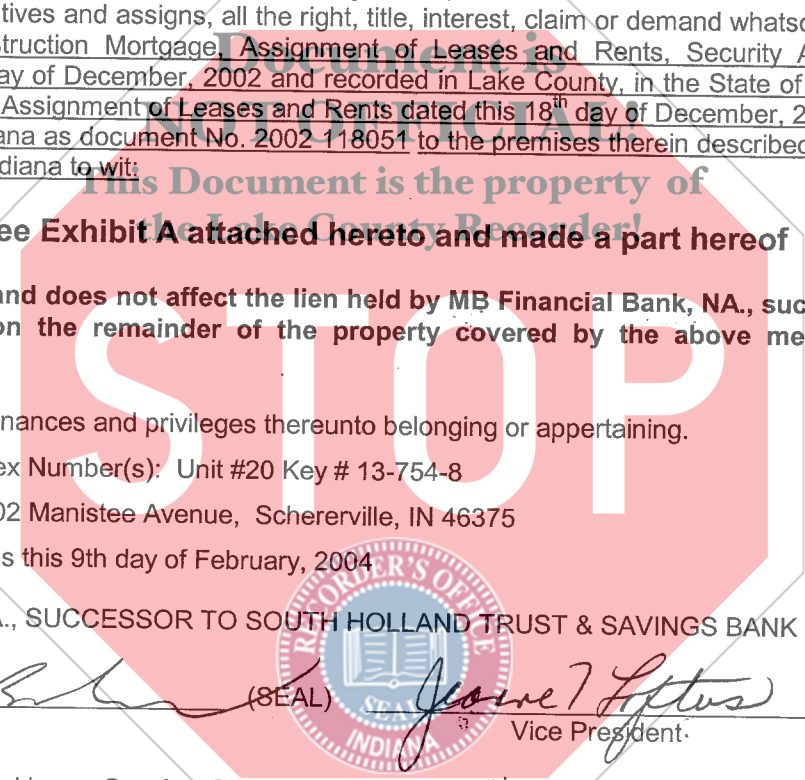

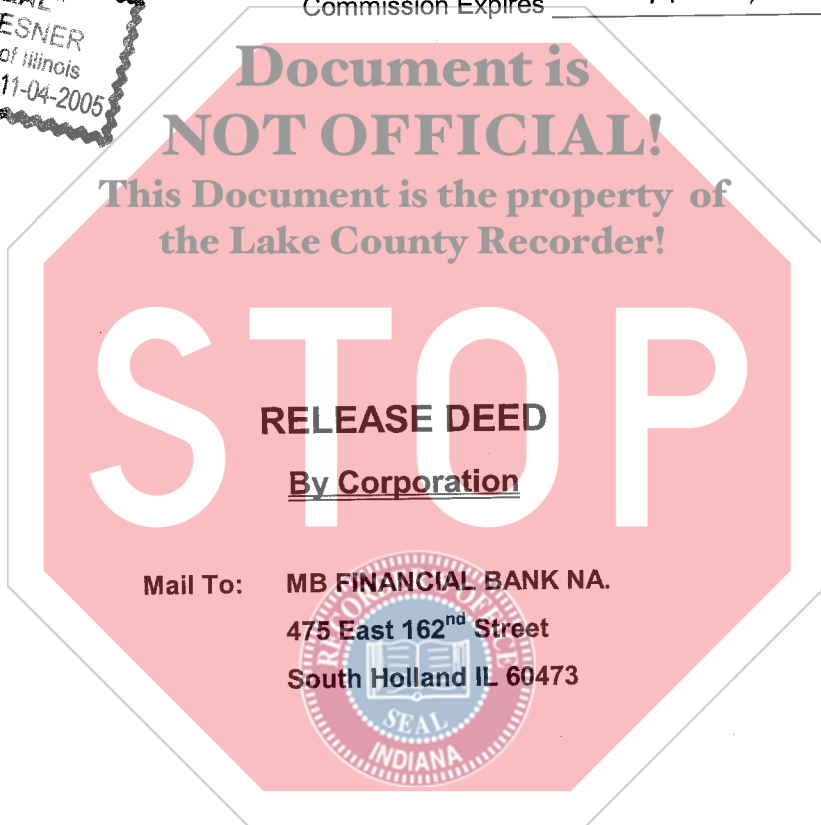


EXHIBIT A

LEGAL DESCRIPTION
