- CONTINUOUS** until cancelled by Surety

It is hereby agreed and understood:

- (1) Regardless of the number of years this bond shall remain in force and the number of annual premiums paid thereafter, the aggregate liability of the Surety hereunder is limited to the penal sum of this bond and any payment or payments made shall reduce the amount of the bond to the extent of such payment or payments.
- (2) That the surety company reserves the right to cancel this bond by giving ninety (90) days written notice to the obligee and on the effective date of such ninety (90) day cancellation notice, the surety is discharged and relieved of any liability, it being understood and agreed, however, that the said principal and said surety will be liable for any loss accruing up to the effective date of said ninety (90) day cancellation notice, in no event, however, in excess of the penalty of the bond.

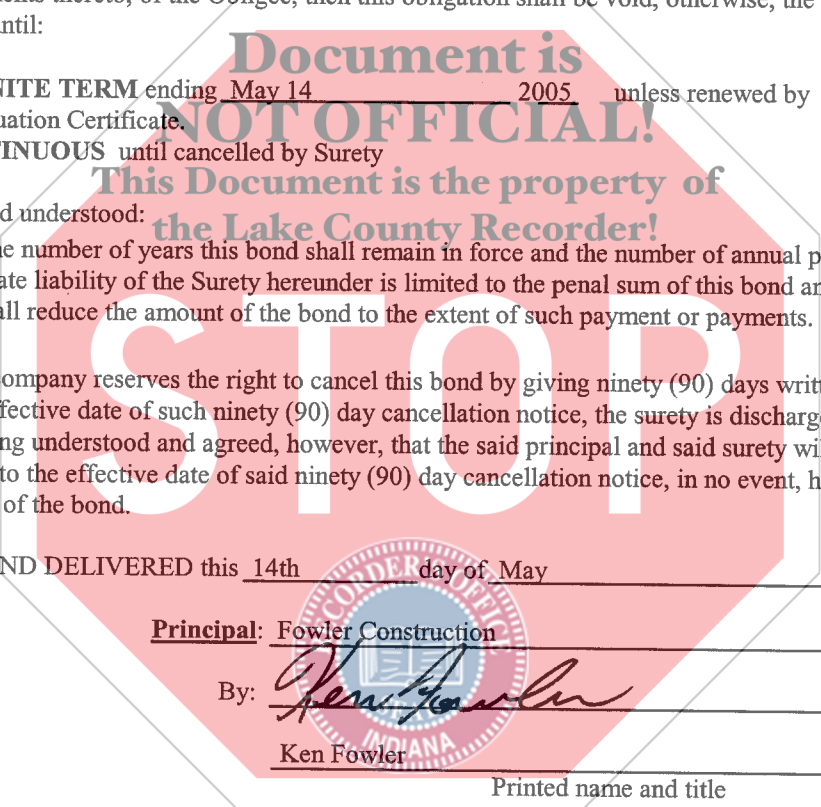

Any such power so executed and sealed and certified by certificate so executed and sealed shall, with respect to any bond or undertaking to which it is attached, continue to be valid and binding on the Company."
