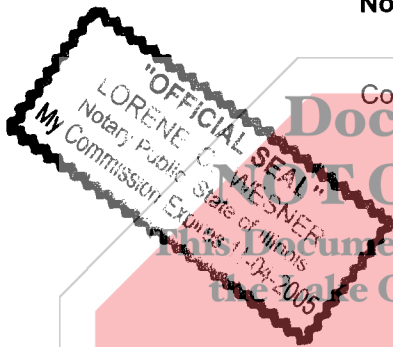

LEGAL DESCRIPTION
