MEMORANDUM OF RESTATEMENT OF THE

a. Therese M. McLaughlin

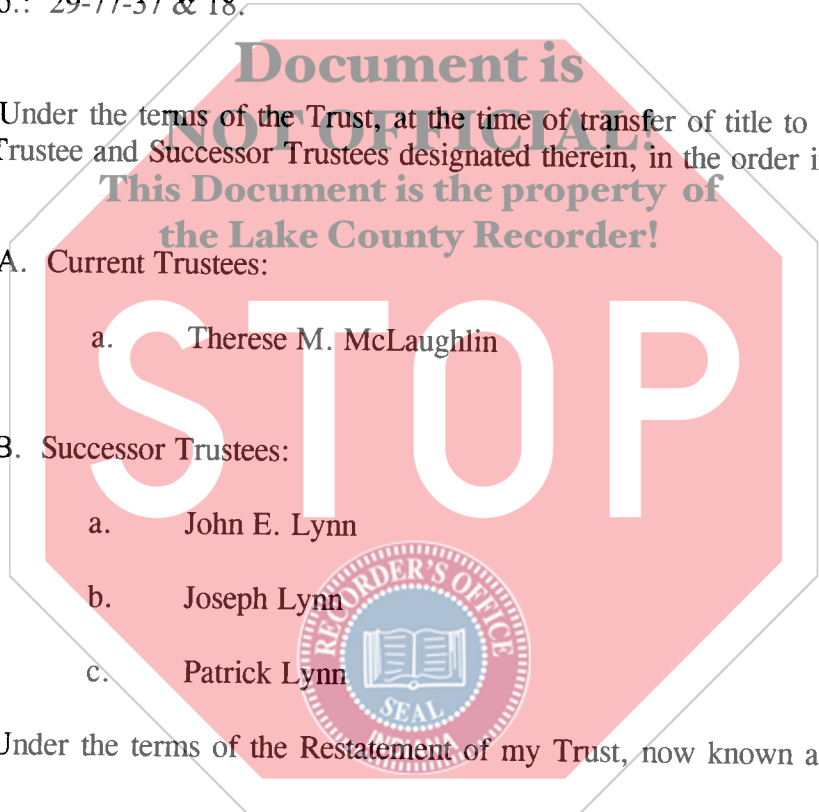
B. Successor Trustees:
