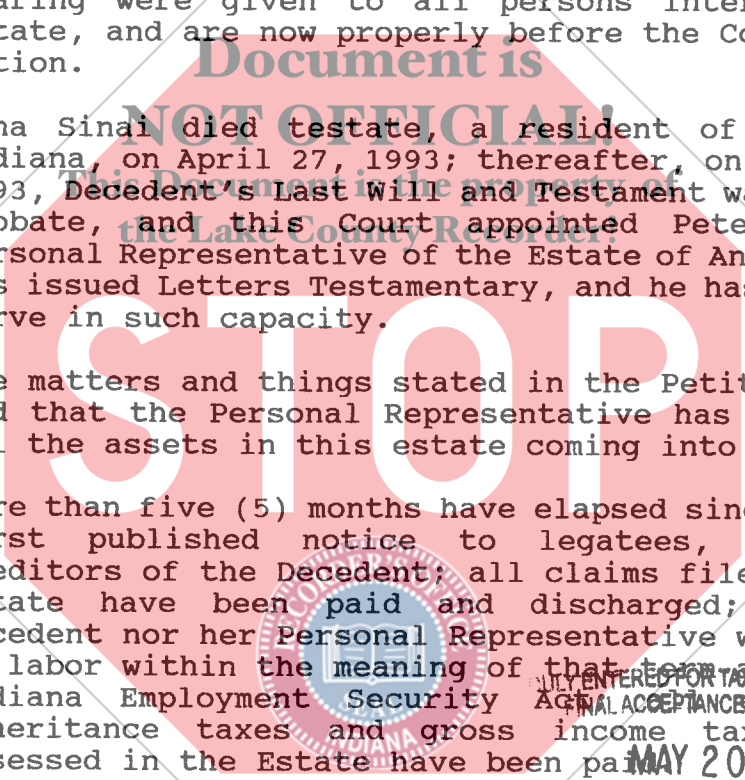

**ORDER APPROVING PERSONAL REPRESENTATIVE'S PETITION  
TO CLOSE ESTATE WITHOUT FINAL ACCOUNTING**

This cause came to be heard on June 18, 1996, upon the Personal Representative's Petition to Close Estate Without Final Accounting, filed by Peter Kahanik, as Personal Representative of the Estate of Anna Jurcak, Deceased.

No objections were filed and the Court being advised now finds that:

1. Due notices of the filing of the Petition and of the hearing were given to all persons interested in the Estate, and are now properly before the Court for final action.
2. Anna Sinai died testate, a resident of Lake County, Indiana, on April 27, 1993; thereafter, on September 30, 1993, Decedent's Last Will and Testament was admitted to probate, and this Court appointed Peter Kahanik as Personal Representative of the Estate of Anna Jurcak, and was issued Letters Testamentary, and he has continued to serve in such capacity.
3. The matters and things stated in the Petition are true, and that the Personal Representative has accounted for all the assets in this estate coming into his hands.
4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of the Decedent; all claims filed against the Estate have been paid and discharged; neither the Decedent nor her Personal Representative were employers of labor within the meaning of that term in the Indiana Employment Security Act; inheritance taxes, inheritance taxes and gross income taxes, if any, assessed in the Estate have been paid.
5. Peter Kahanik is the sole legatee and under the Decedent's Last Will and Testament, all assets of the Decedent's Estate have been administered upon and distribution of the balance in the Estate, after payment of all debts and obligations, has been made; all obligations of the Personal Representative have been

Lot 20, Block 2, Lake Addition to Hammond, as per the recorded plat thereof in the Recorder's Office, Lake County, Indiana;

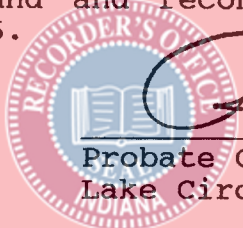
