### ASSIGNMENT OF MORTGAGE

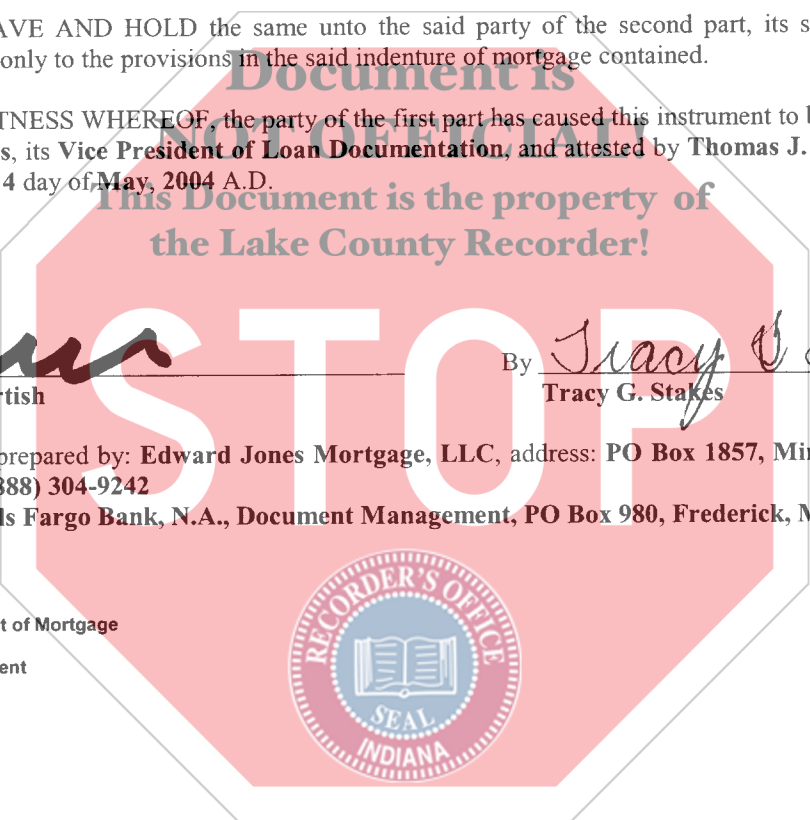



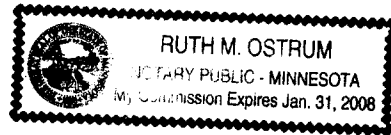
