for the payment of which well and truly to be made, we jointly and severally bind ourselves, our heirs, executors and administrators.

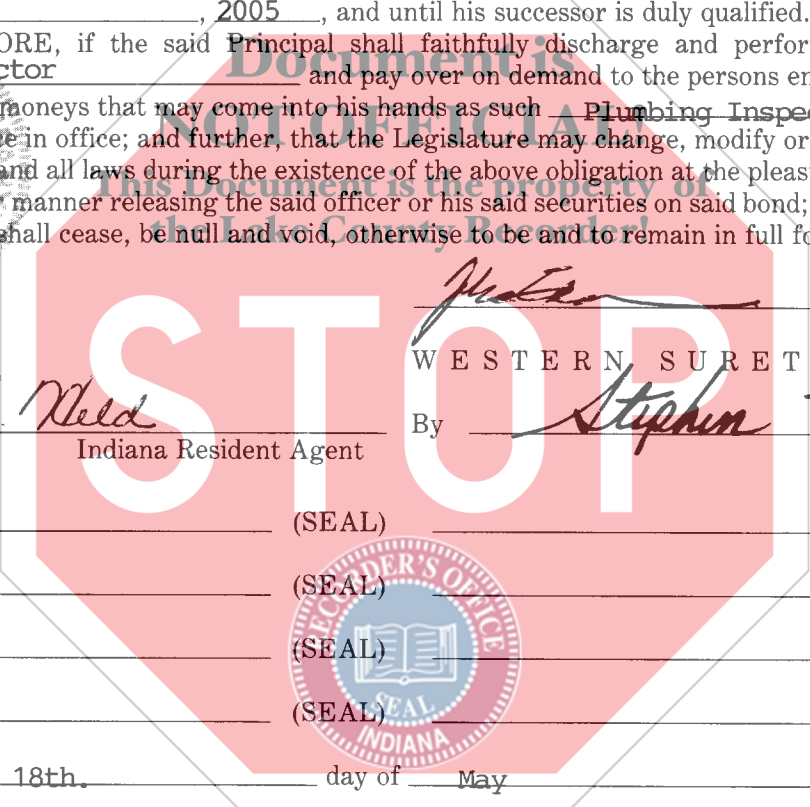

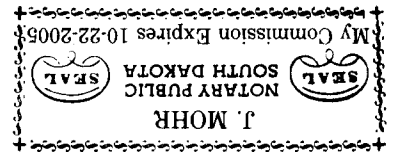

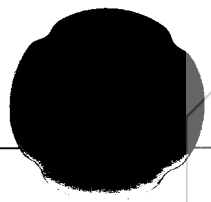
