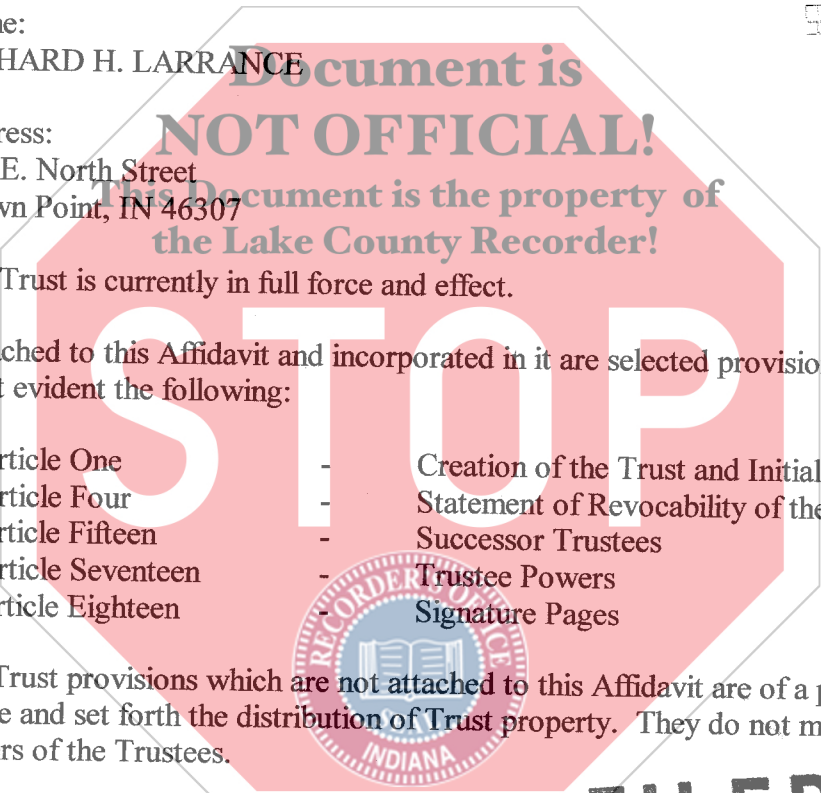
5. The Trust is currently in full force and effect.

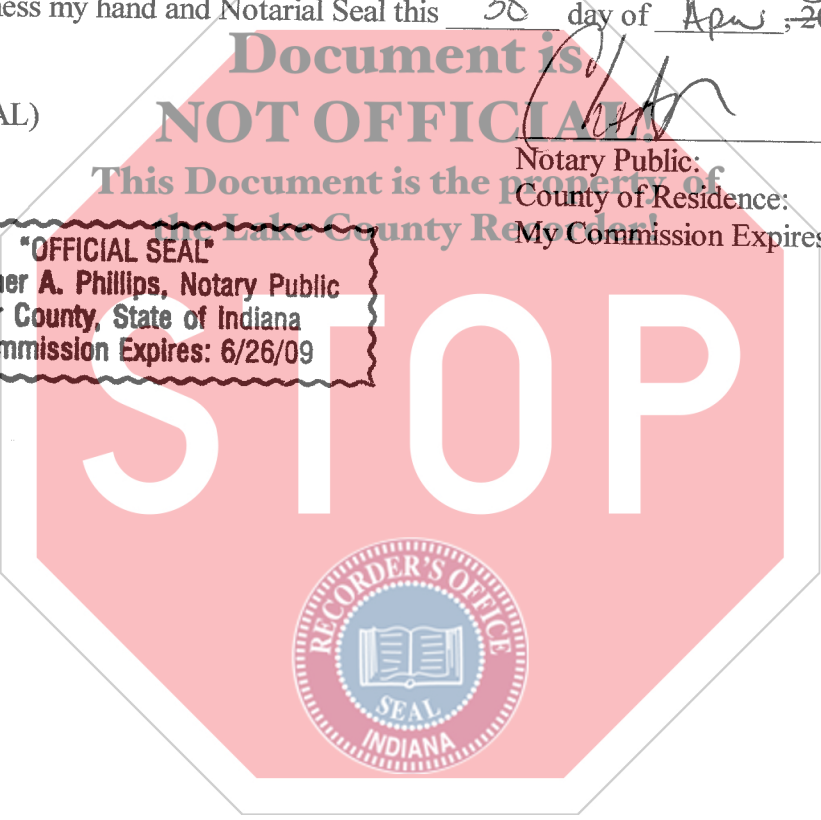
