THIS INDENTURE, Made this 2nd day of April, A.D. 2004 between Rogelio "Roy" Dominguez, Sheriff of Lake County, in the State of Indiana, of the first part and CITIZENS FINANCIAL SERVICES, FSB, of the County of Lake and State of Indiana of the second part, WITNESSETH:

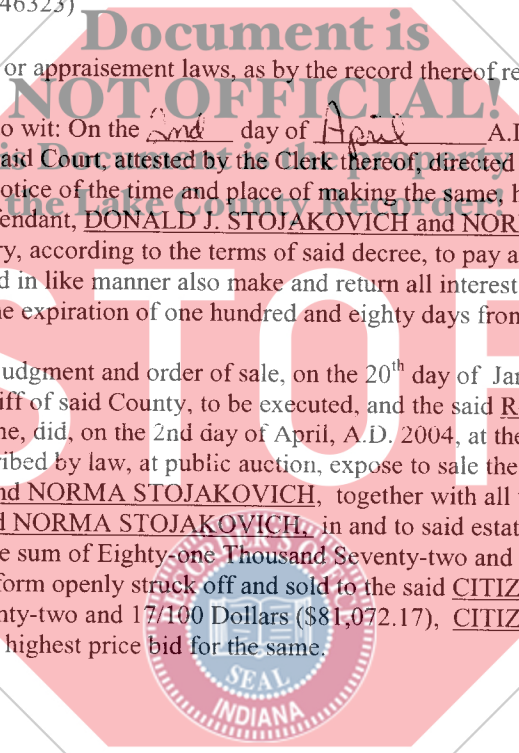
THAT WHEREAS, At the Continuous Term of the Lake Superior Court A.D. 2004, CITIZENS FINANCIAL SERVICES, FSB recovered by judgment of said Court, in a certain action therein against DONALD J. STOJAKOVICH and NORMA STOJAKOVICH, the sum of Eighty-one Thousand Fifty-nine and 17/100 Dollars (\$81,059.17) for its damages, together with the further sum of Thirteen Dollars and No Cents, (\$13.00) for its costs in that behalf expended; and a decree for the sale of all the interest, estate, right and title of the defendant, DONALD J. STOJAKOVICH and NORMA STOJAKOVICH, in and to certain Real Estate, described therein as follows, to-wit:

Lot 18, Block 1, Hessville Gardens, Hammond, as shown in Plat Book 16, page 27, in the Office of the Recorder of Lake County, Indiana. (Commonly known as 6546 California Avenue, Hammond, IN 46323)

All without relief whatever from valuation or appraisal laws, as by the record thereof remaining in said Court more fully appears.

AND, WHEREAS, Afterwards, to wit: On the 2nd day of April A.D. 2003, a copy of said judgment and decree was duly issued, and under seal of said Court, attested by the Clerk thereof, directed to the Sheriff of the County of Lake, commanding him that after due and legal notice of the time and place of making the same, he should sell the above-described, with all the interest, estate, right and title of the defendant, DONALD J. STOJAKOVICH and NORMA STOJAKOVICH, together with all the rights, title and interest in fee simple of the said DONALD J. STOJAKOVICH and NORMA STOJAKOVICH, in and to said estate, and the said CITIZENS FINANCIAL SERVICES, FSB did then and there bid the sum of Eighty-one Thousand Seventy-two and 17/100 Dollars (\$81,072.17), and no person bidding more, the same was in due form openly struck off and sold to the said CITIZENS FINANCIAL SERVICES, FSB, for the said sum of Eighty-one Thousand Seventy-two and 17/100 Dollars (\$81,072.17), CITIZENS FINANCIAL SERVICES, FSB, being the highest bidder, and that being the highest price bid for the same.

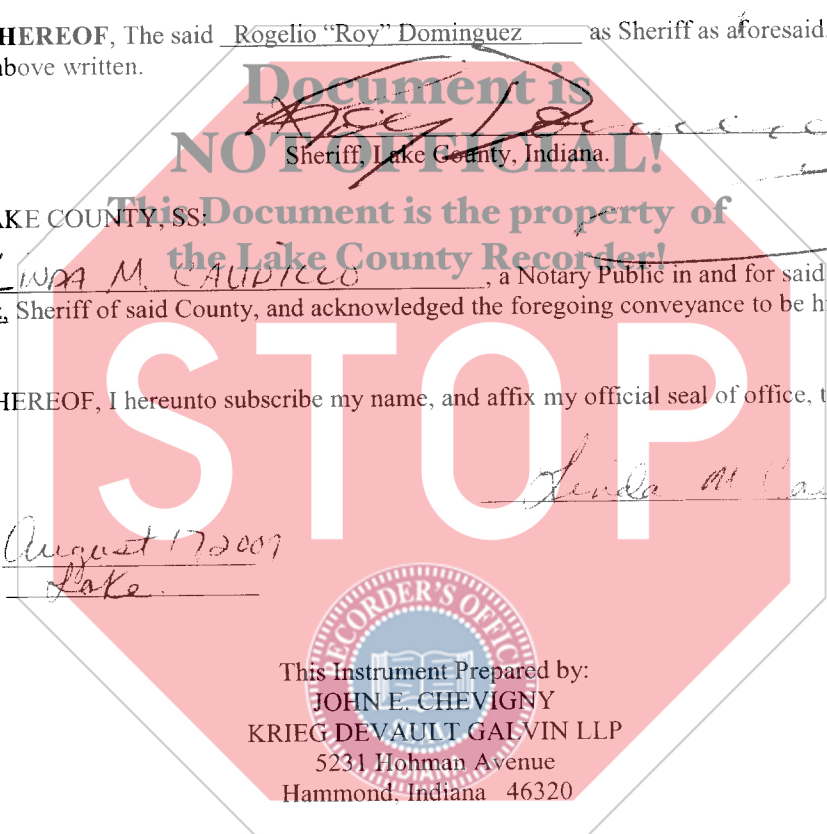
