2. That she was a daughter of STANLEY INKLEY and KATHERINE A. INKLEY.
3. That STANLEY INKLEY was married once and only once and that was to KATHERINE A. INKLEY. There were two children born as a result of that marriage; namely, KATHRYN LEACH and ELIZABETH I. SHALETT. There were no other children born to or adopted by STANLEY INKLEY or KATHERINE A. INKLEY. Said STANLEY INKLEY died on February 24, 1995 and was survived by his wife, KATHERINE A. INKLEY; his daughter, KATHRYN LEACH, and his daughter, ELIZABETH I. SHALETT.
4. That said KATHRYN LEACH died on October 29, 1998 and was survived by her children, SARAH LEACH, JONATHON LEACH and K. AMANDA LEACH. KATHERINE A. 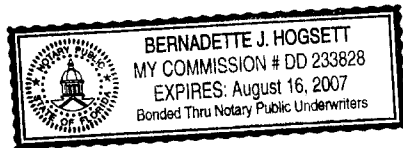
