# TAX DEED

**WHEREAS** LIBERTY FLOURNOY did the 14th day of November, 2003 produce to the undersigned, STEPHEN R. STIGLICH Auditor of the County of Lake in the State of Indiana, a certificate of sale dated the 19th day of March, 2003, signed by STEPHEN R.
