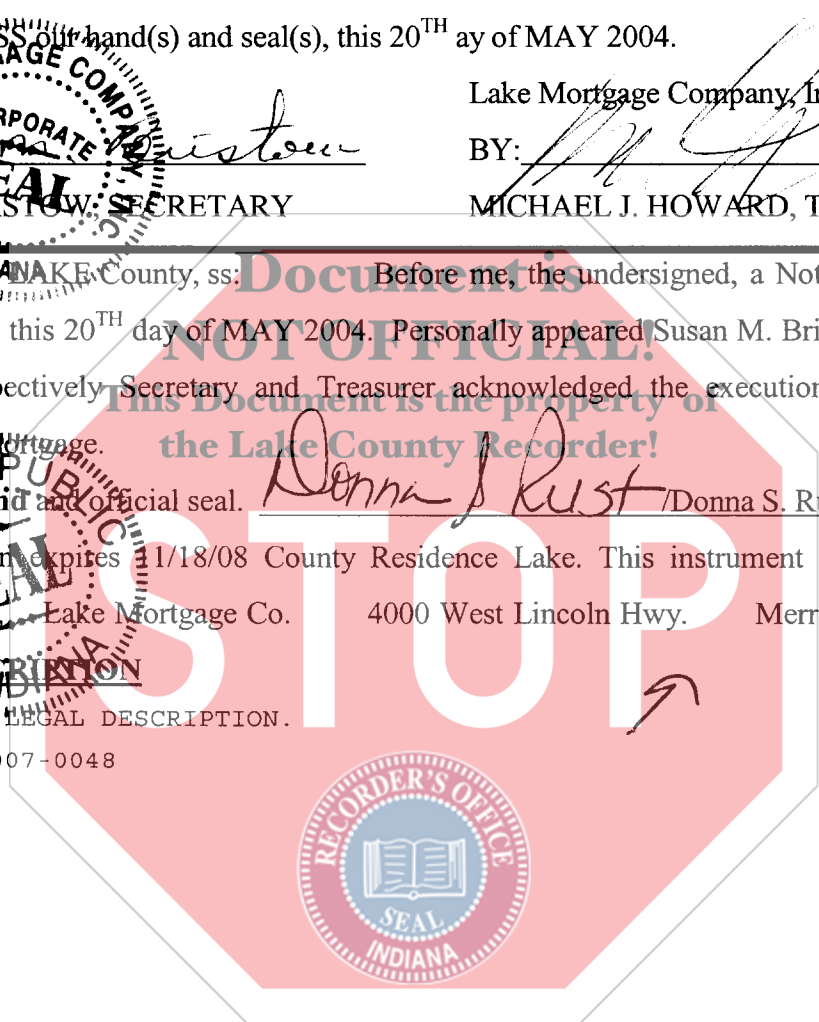

RIDER - LEGAL DESCRIPTION

PART OF THE EAST HALF OF THE WEST 2/3RDS OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 26, TOWNSHIP 36 NORTH, RANGE 9 WEST OF THE 2ND PRINCIPAL MERIDIAN, IN LAKE COUNTY, INDIANA, DESCRIBED AS COMMENCING AT A POINT IN THE CENTER LINE OF RIDGE ROAD WHICH POINT IS 148.28 FEET EASTERLY MEASURED ON SAID CENTER LINE FROM THE WEST LINE OF SAID EAST HALF (SAID POINT BEING THE NORTHEAST CORNER OF THE TRACT OF LAND CONVEYED TO ISAAC MILLS AND MARTHA MILLS, HUSBAND AND WIFE, BY WARRANTY DEED DATED OCTOBER 25TH, 1943 AND RECORDED NOVEMBER 5TH, 1943, IN DEED RECORD 687, PAGE 446), RUNNING THENCE EAST ON CENTER LINE OF SAID ROAD 70 FEET, THENCE SOUTH PARALLEL WITH THE WEST LINE OF THE EAST HALF OF THE WEST 2/3RDS, 722.89 FEET, MORE OR LESS, TO A POINT 20.0 FEET NORTH OF THE SOUTH LINE OF SAID QUARTER QUARTER SECTION, THENCE WEST TO A POINT DUE SOUTH OF THE BEGINNING, THENCE NORTH 741.78 FEET, MORE OR LESS TO THE POINT OF BEGINNING, IN THE TOWN OF GRIFFITH, LAKE COUNTY, INDIANA.
