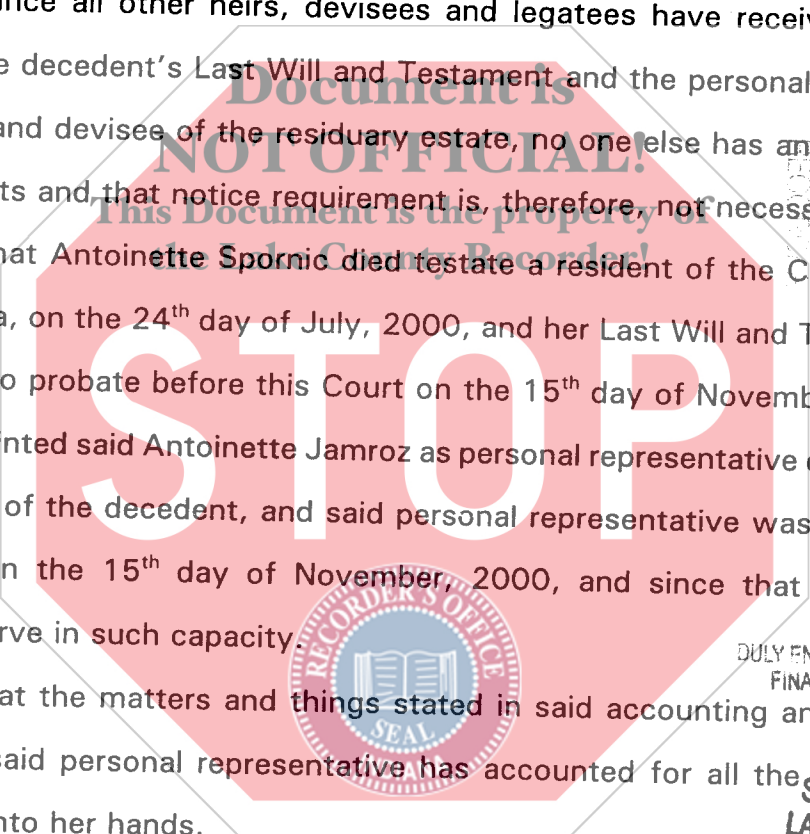
This cause came to be heard on the 25th day of May, 2004, upon the Final Accounting, Petition to Settle and Allow, and for Authority to Distribute Estate filed by Antoinette Jamroz as personal representative of the Estate of Antoinette Spornic, deceased, which account and petition are on file with the Court and made part of the court's record.

1. Since all other heirs, devisees and legatees have received their share pursuant to the decedent's Last Will and Testament and the personal representative is the legatee and devisee of the residuary estate, no one else has an interest in the remaining assets and that notice requirement is, therefore, not necessary.

2. That Antoinette Spornic died testate a resident of the County of Lake, State of Indiana, on the 24th day of July, 2000, and her Last Will and Testament was duly admitted to probate before this Court on the 15th day of November, 2000, and this Court appointed said Antoinette Jamroz as personal representative of the Last Will and Testament of the decedent, and said personal representative was issued letters testamentary on the 15th day of November, 2000, and since that date she has continued to serve in such capacity.

3. That the matters and things stated in said accounting and petition are true, and that said personal representative has accounted for all the assets in this estate coming into her hands.

4. More than five months have elapsed since the date of the first published notice to the legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her personal representative were employers of labor within the meaning of that term as used in the

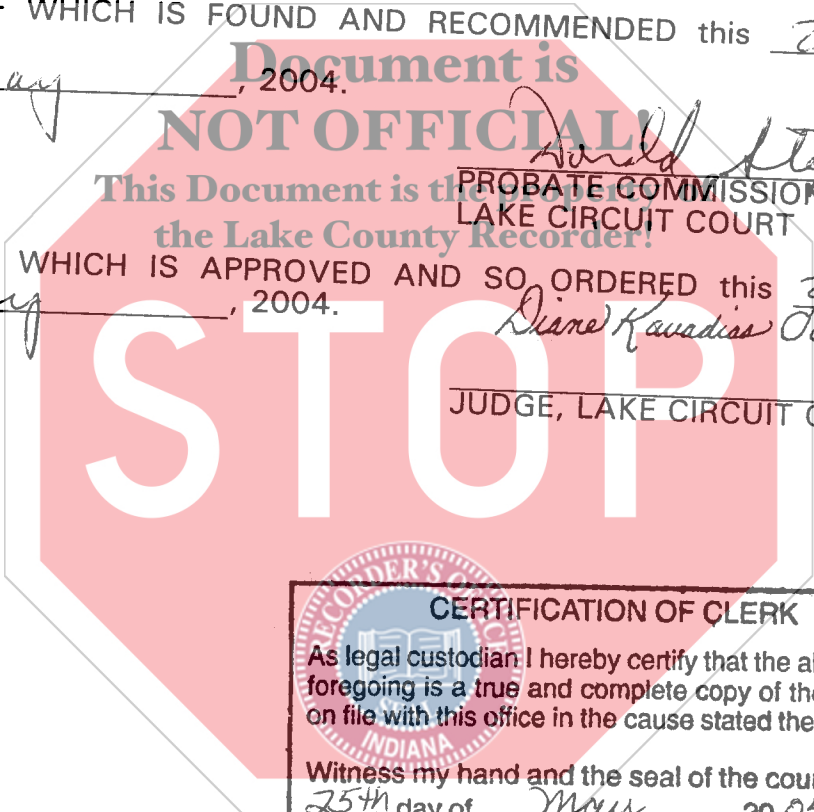
5. Said personal representative is hereby released and discharged from any further liability or responsibility along with her surety as personal representative of the estate of Antoinette Spornic.
