It is further and agreed that if the Surety shall so elect, this bond may be cancelled by giving thirty days notice in writing to said Obligee.

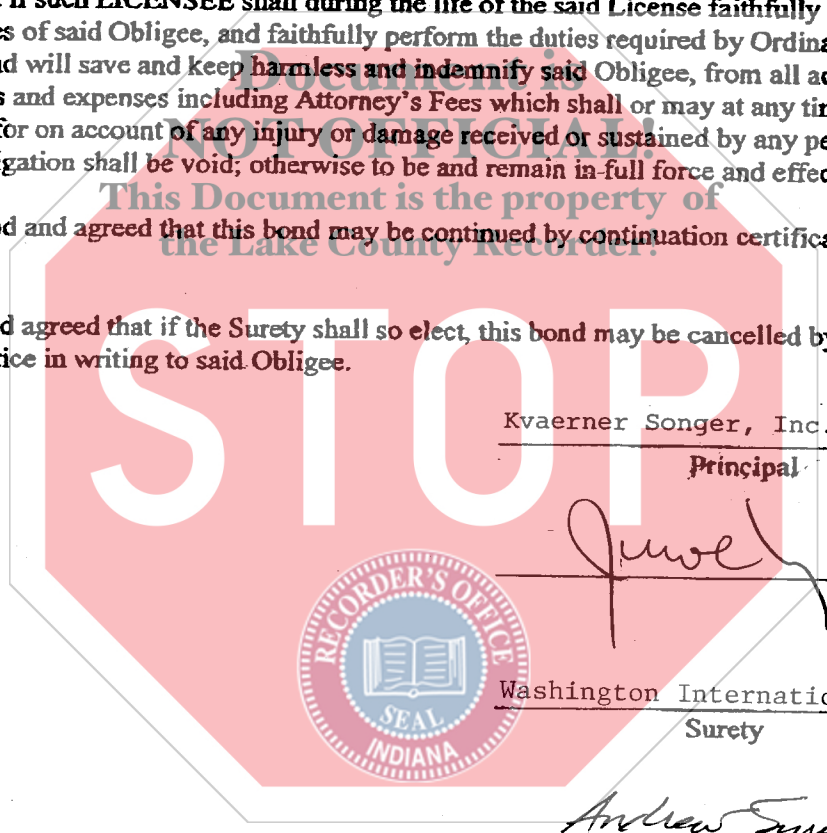

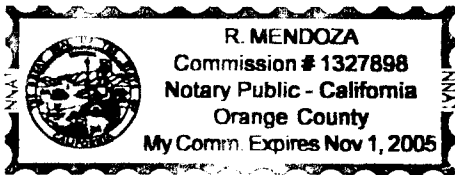
