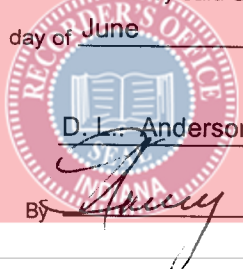
WHEREAS, the said Principal has applied to said Obligee for a license to or permit as a concrete contractor
