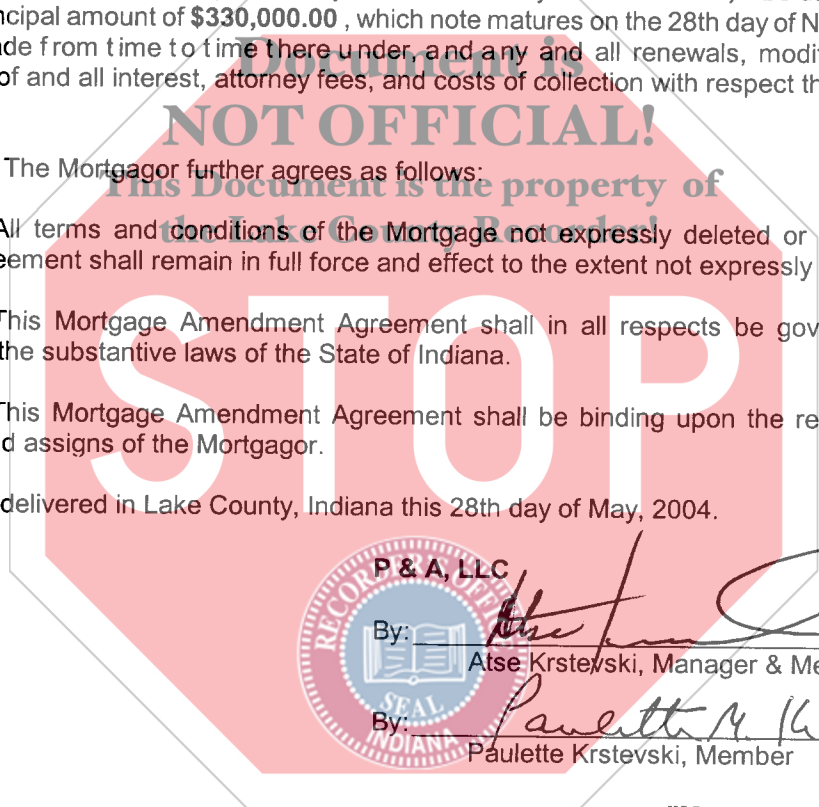
MORTGAGE MODIFICATION AGREEMENT

Mortgagor, for valuable consideration given by Mortgagee, the receipt and sufficiency of which is hereby acknowledged, does hereby agree that the certain Mortgage dated the 5th day of December, 2002, recorded the 7th day of February, 2003, in the Office of the Recorder of Lake County, Indiana, as Document No. **2003013929** (herein the "Mortgage"), is hereby amended as follows:

The promissory note referenced in paragraph 1 of the Mortgage in the original principal amount of **\$1,530,216.79** and dated the 5th day of December, 2002, (herein the "Note") has been modified as follows:

1. **Additional Indebtedness Secured by Mortgage.** In addition to the obligations referred to in the Mortgage it shall also secure payment of that certain promissory note executed by **Vision Point II, LLC** dated the 28th day of May, 2004 in the original principal amount of **\$330,000.00**, which note matures on the 28th day of November, 2004, together with all advances made from time to time there under, and any and all renewals, modifications, replacements and extensions thereof and all interest, attorney fees, and costs of collection with respect thereto.
2. **Miscellaneous.** The Mortgagor further agrees as follows:
 - A. All terms and conditions of the Mortgage not expressly deleted or amended by this Mortgage Amendment Agreement shall remain in full force and effect to the extent not expressly inconsistent herewith.
 - B. This Mortgage Amendment Agreement shall in all respects be governed by and construed in accordance with the substantive laws of the State of Indiana.
 - C. This Mortgage Amendment Agreement shall be binding upon the respective heirs, successors, administrators and assigns of the Mortgagor.



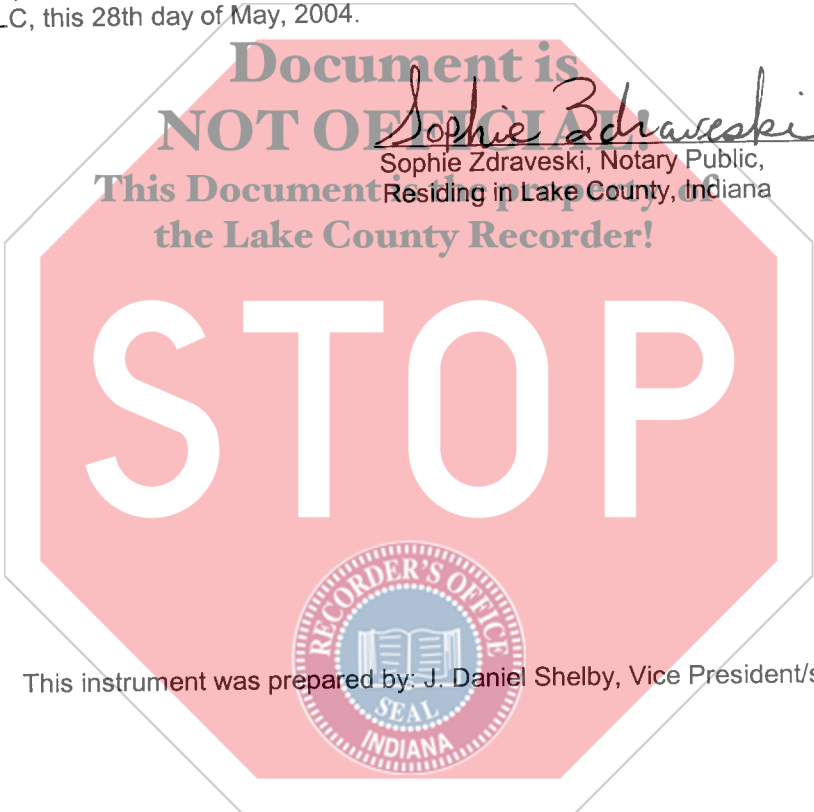
