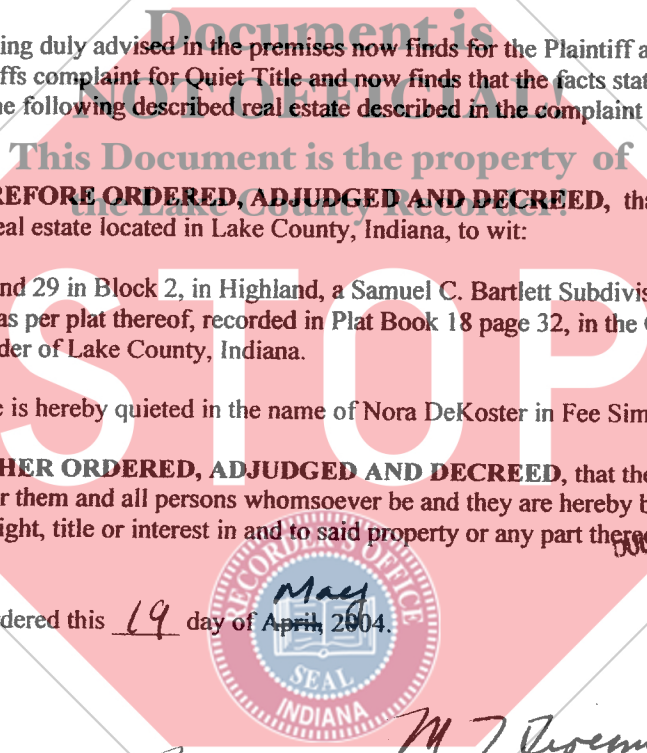

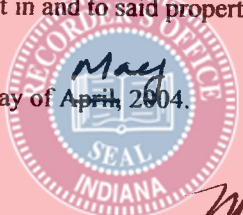
IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, that the title to the following described real estate located in Lake County, Indiana, to wit:
