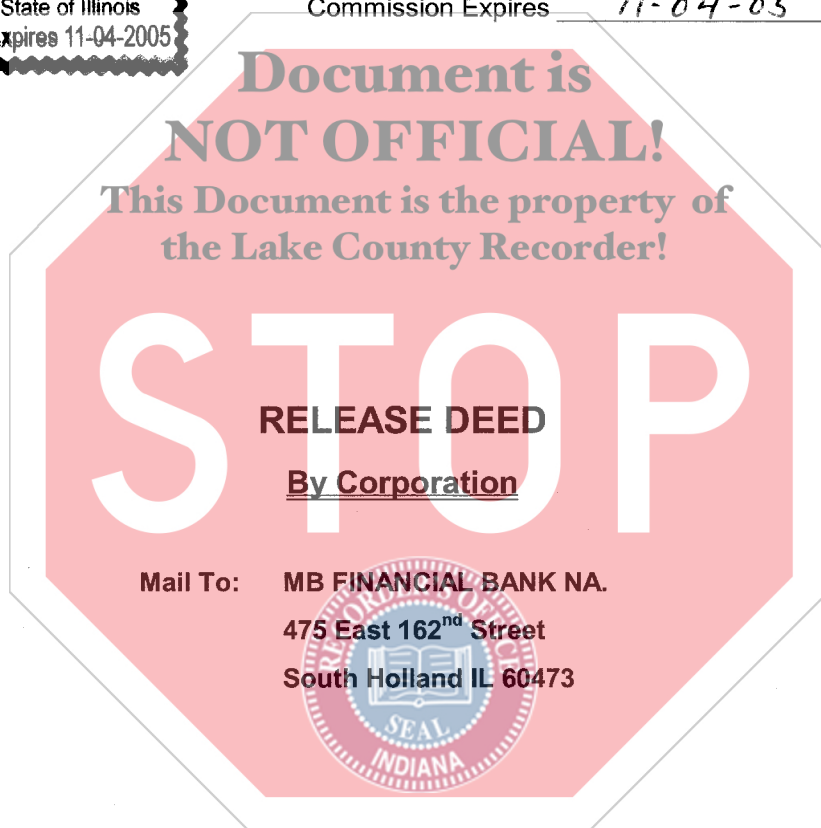
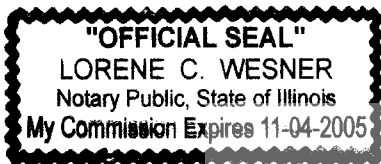


EXHIBIT A
