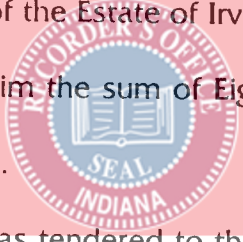
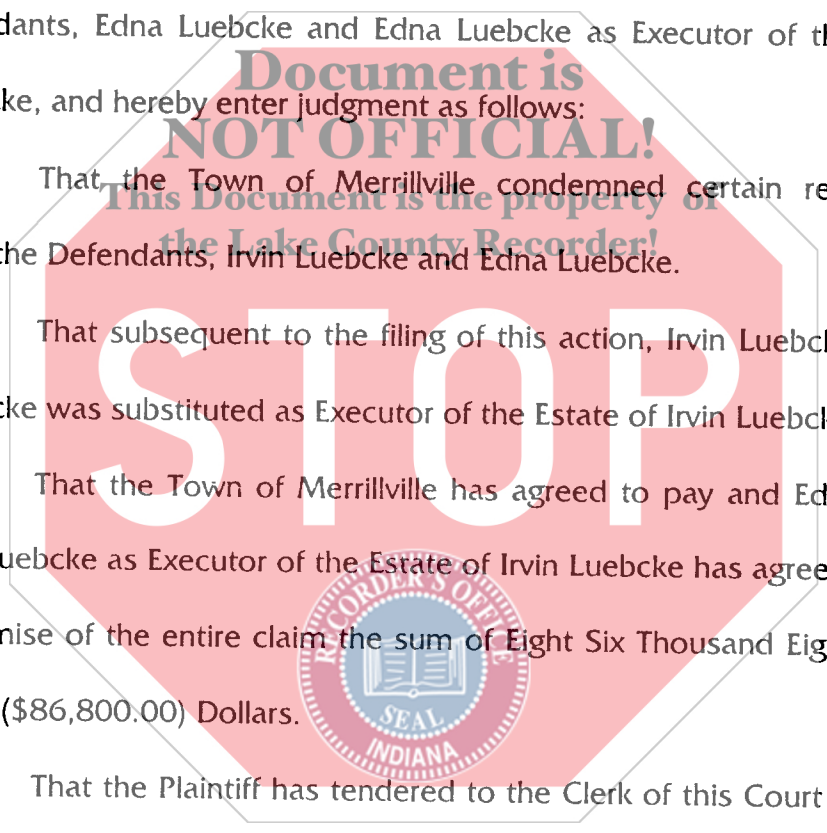

Comes now the Plaintiff, Town of Merrillville, by Geoffrey G. Giorgi, and the Defendants, Edna Luebcke and Edna Luebcke as Executor of the Estate of Irvin Luebcke, and hereby enter judgment as follows:

1. That the Town of Merrillville condemned certain real property owned by the Defendants, Irvin Luebcke and Edna Luebcke.
2. That subsequent to the filing of this action, Irvin Luebcke died and Edna Luebcke was substituted as Executor of the Estate of Irvin Luebcke.
3. That the Town of Merrillville has agreed to pay and Edna Luebcke and Edna Luebcke as Executor of the Estate of Irvin Luebcke has agreed to accept in compromise of the entire claim the sum of Eight Six Thousand Eight Hundred and 00/100 (\$86,800.00) Dollars.
4. That the Plaintiff has tendered to the Clerk of this Court the sum of \$43,400.00 and agrees to pay an additional Forty Three Thousand Four Hundred




