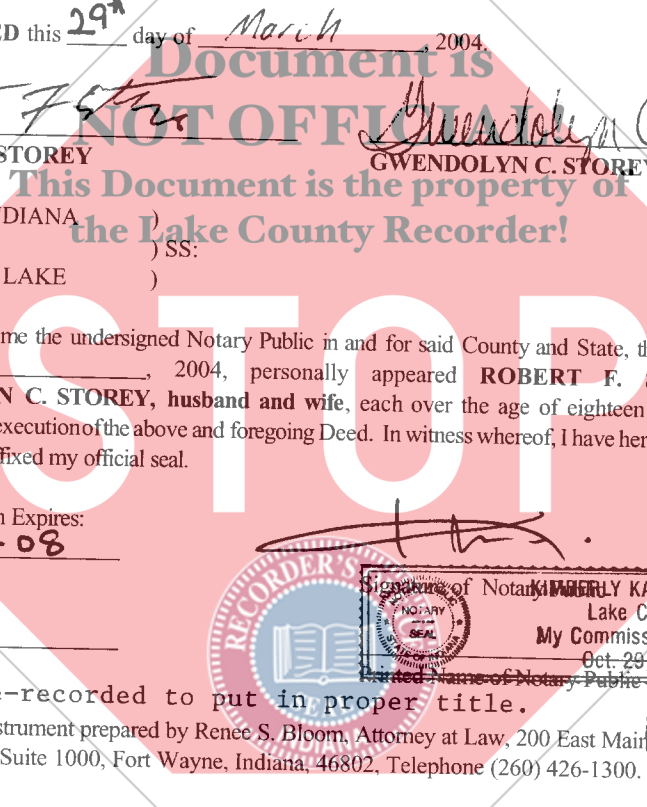
This deed is given to correct the legal description which was incorrectly described on the original plat, survey, deeds, and mortgages, and to correctly vest title to the proper parties in interest.
