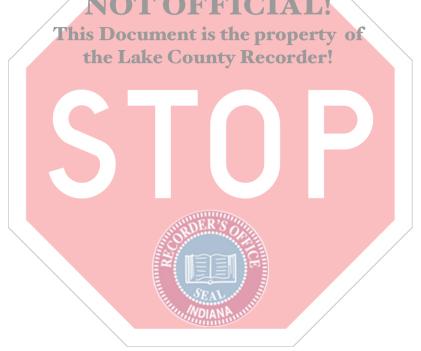

Barney's Gary Park Addition to Hobart, as per plat thereof, recorded in Plat Book 10 page 6, in the Office of the Recorder of Lake County, Indiana, said lots were vacated September 8, 1949 by virtue of proceedings had in Lake Circuit Court at Crown Point, Indiana, as Cause #33143 and now more particularly described as follows; to-wit: The South 50 feet of the East 125 feet of the following described parcel to-wit: Part of the North 1/2 of the East 1/2 of the Southeast 1/4 of the Northwest 1/4 of Section 26, Township 36 North, Range 8 West of the 2nd Principal Meridian, in the City of Hobart, Lake County, Indiana, described as follows: Beginning at a point on the North line of the Southeast 1/4 of the Northwest 1/4 of said Section and 364.6 feet East of the Northwest corner thereof; thence South along the East line of Howard Street a distance of 426.5 feet; thence East 265.47 feet to a point on the West line of Colbourne Street, which point is 426.75 feet South of the North line thereof; thence North 426.75 feet along the West line of Colbourne Street to the North line of the Southeast 1/4 of the Northwest 1/4 of said Section; thence West 265.6 feet to the Point of Beginning.
