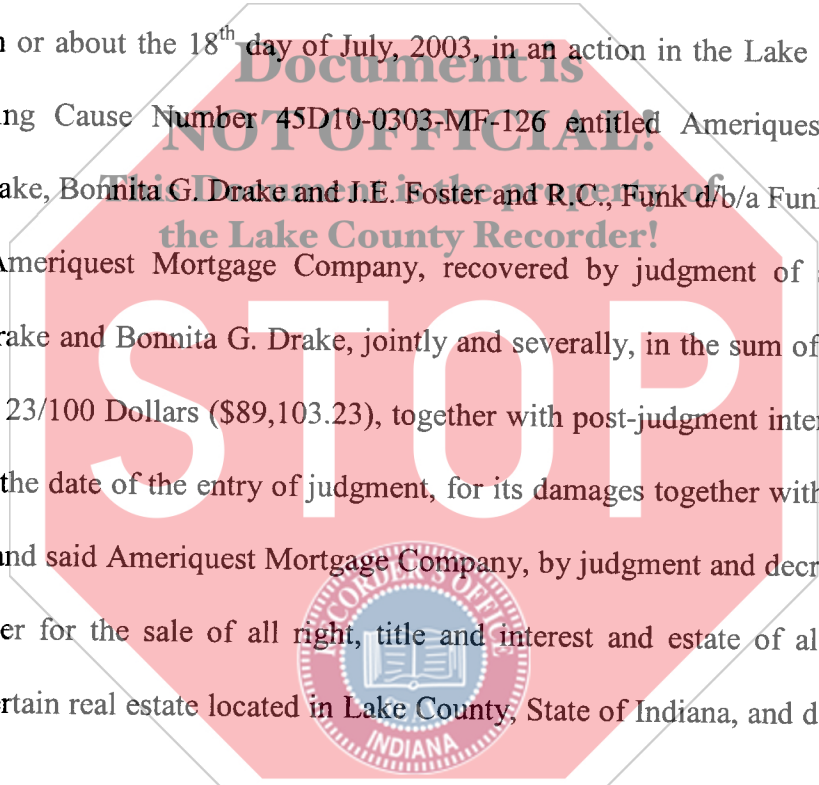

**SHERIFF'S DEED ON DECREE**

This indenture made this 7<sup>th</sup> day of May, 2004, by and between **ROGELIO "ROY" DOMINGUEZ**, Sheriff of Lake County, Indiana, as First Party, and **AMERIQUEST MORTGAGE COMPANY**, as Second Party.

**WITNESSETH:**

**WHEREAS**, on or about the 18<sup>th</sup> day of July, 2003, in an action in the Lake Superior Court of Lake County, Indiana, bearing Cause Number 45D10-0303-MF-126 entitled Ameriquest Mortgage Company, Plaintiff vs. Scott A. Drake, Bonnita G. Drake and J.E. Foster and R.C. Funk d/b/a Funk & Foster, Defendants, the Plaintiff therein, Ameriquest Mortgage Company, recovered by judgment of said Court against the Defendants, Scott A. Drake and Bonnita G.
