### Road Transfer Memorandum of Agreement

2001; 055129
This Agreement is made and entered into on March 22, 200 , by and between the State of Indiana and through the Indiana Department of Transportation (hereinafter referred to as INDOT), Lake County, acting by and through its County Commissioners (hereinafter referred to as COUNTY), and the City of Gary, acting by and through its authorized officials (hereinafter referred to as CITY).

### WITNESSETH:

WHEREAS, the CITY is actively preparing, as an integral part of its Lake Front Development Project DPM/0045(001), for the construction of a new multi-phased Gary Marina access road from the existing US 12/SR 912 Interchange to the Buffington Harbor area at the Gary Marina (DES# 9380960);

NOTOFFICIAL!

WHEREAS, the Gary/Chicago Airport in conjunction with the CITY is currently proposing as part of its long range plan, the extension of two runways and a long term consideration for the construction of a new crosswind runway (12L-30R) that would require the relocation or elimination of that portion of existing U.S. 12 adjacent and contiguous to the Airport;

WHEREAS, pursuant to established planning criteria and Indiana Code Sections 8-23-4-2 and 8-23-4-10, INDOT has determined, and the CITY and COUNTY agree, that US 12 from existing SR 912 to its northern junction with existing US 20 (at Bridge Street) and SR 312 from SR 912 to US 12 will no longer be the most appropriate and/or convenient ways for INDOT to route state traffic, but the roads will continue to serve a useful local purpose;

WHEREAS, I.C. 8-23-4-12 provides the means to transfer roads or streets between systems; and



NOW, THEREFORE, in consideration of the premises and the mutually dependent covenants, the parties agree as follows:

- Section 1 The parties hereto shall comply with applicable provisions set forth in (1) Title 23 of the US Code, (2) the regulations issued thereto, and (3) the policies and procedures of the Federal Highway Administration relative to the work covered by and the roads transferred in this Agreement.
- Section 2 INDOT agrees, upon completion of the transfers itemized in Section 3 and Section 4, to convey to the CITY the two parcels of land more fully described in EXHIBIT B (attached hereto and made a part hereof)

- Section 3 INDOT shall transfer, and the CITY shall accept,
  maintenance jurisdiction of the following road segments
  (see Exhibit A, attached hereto and made a part hereof):
  - ITEM G-1 Existing alignment of US 12, from its intersection with the eastern ramps at SR 912 to the western right-of-way setback at its intersection with US 12 (Bridge Street), approximately 3.80 miles.
  - ITEM G-2 Existing alignment of SR 312, from the eastern North/South collector-distributor ramp for SR 912 to existing US 12, approximately 0.59 mile.
- Section 4 INDOT shall transfer, and the COUNTY shall accept, maintenance jurisdiction of the following bridge structures on existing US 12 (see Exhibit A, attached hereto and made a part hereof):
  - ITEM C-1 Existing structure (Bridge #8001) over the Grand Calumet River, excluding any roadway approaches and electrical systems and fixtures.

ITEM C-2 Existing structure (Bridge #2080) over the NICTD Railroad, excluding any roadway approaches and electrical systems and fixtures.

- Section 5 Limited access provisions, if any, shall continue to apply for all right-of-way acquired as part of this transfer.
- Section 6 INDOT shall officially notify both the CITY and the COUNTY by separate certified letters to formally establish the date and time of transfer for the roads and bridges described in Sections 3 and 4. The effective date of the transfers shall be determined by INDOT and shall be a date no later than two weeks from the final date of approval of this Agreement.
- Section 7 Immediately after the effective date of transfer established in Section 6, the CITY and COUNTY shall provide all future maintenance, reconstruction and construction for their respective portions of the roads and the bridges described in Sections 3 & 4 (including all traffic and safety devices and appurtenances) of this Agreement.
- Section 8 Immediately after the effective date of transfer, electrical energy, if any, required to operate the facilities, traffic signals, and lights along the roads in Sections 3 & 4 of this Agreement shall be paid by the CITY.
- Section 9 In addition to the transfer described above, INDOT also agrees to complete, at its expense, the replacement of existing structure (Bridge #2045) over the CSXT & NS Railroad (Bridge Replacement Project DES# 9701860).

Section 10 Upon completion of the project listed in Section 9, the COUNTY shall then accept maintenance jurisdiction of the following bridge structure on existing US 12 (see Exhibit A, attached hereto and made a part hereof):

<u>ITEM C-3</u> Existing structure (Bridge #2045) over the CSXT & NS Railroad, excluding any roadway approaches and electrical systems and fixtures.

Section 11 INDOT shall officially notify the COUNTY by another separate certified letter to formally establish the date and time of transfer for the bridge described in Section 10. The effective date of the transfer shall be determined by INDOT and shall be a date no later than two (2) weeks from the completion date of the project described in Section 9 of this Agreement.
