PARCEL 1: Lots 1 and 2, in Heritage Estates Addition, Unit 1, to the Town of Dyer, as per plat thereof, recorded in Plat Book 41 page 11, in the Office of the Recorder of Lake County, Indiana.

PARCEL 2: That part of the West Half of Fractional Section 12, Township 35 North, Range 10 West of the 2nd Principal Meridian, in the Town of Dyer, Lake County, Indiana, described as follows: Beginning at a point of the North line of said Section 12, 572.90 feet West of the Northeast corner of the West Half of Section 12, said point also being the Southwest corner of Lot 2, in Heritage Estates Unit 1, to the Town of Dyer, as per plat thereof, recorded in Plat Book 41 page 11, in the Office of the Recorder of lake County, Indiana; thence North 89 degrees 29 minutes East, along the North line of said Section 12, 253.80 feet to a point of curve, said point lying on the South right of way line of Monticello Drive; thence Southeasterly on a curve, the tangent of which makes an angle of 149 degrees 01 minutes 34 seconds from the West to Southeast with the last described line, concave to the Northeast and having a radius of 231.42 feet, a distance of 10.43 feet; thence South 0 degrees 04 minutes 20 seconds East, parallel to the East line of Fractional West Half of said Section 12, 27.84 feet; thence South 89 degrees 29 minutes West; 262.94 feet; thence North 33.0 feet to the point of beginning.
