### LIMITED POWER OF ATTORNEY

Box 65250, Salt Lake City, Utah 84165-0250 ("Fairbanks"), acting by and through Fairbanks' authorized agents, employees, or representatives, as TCIF's duly authorized attorney-in-fact to take the following designated actions with respect to any residential mortgage loan (each, a "Mortgage Loan") in which TCIF REO2 holds an interest or any parcel of improved residential real property acquired by TCIF REO2 by foreclosure, deed in lieu, quit-claim deed, or other, similar process:

- A. endorse the name of TCIF REO2upon all checks, drafts, notes, powers and other forms of exchange received in payment of, or tendered in connection with, a Mortgage Loan;
- B. execute on behalf of TCIF REO2any assignments, documents or instruments necessary to assign, convey, or otherwise transfer an interest in a Mortgage Loan to and/or from TCIF REO2;
- execute on behalf of TCIF REO2 any documents necessary to carry out the foreclosure of a Mortgage Loan;
- D. execute any documents necessary to effectuate an eviction, unlawful detainer or similar dispossessory proceeding;
- E. execute any documents necessary for the offer, listing, closing of sale and conveyance of real estate owned ("REO") property; and my Recorder!
- F. perform all other acts and do all other things as may be necessary or convenient to service a Mortgage Loan or convey an REO property.

The foregoing indemnity shall survive the termination of this Limited Power of Attorney.

This Limited Power of Attorney is entered into and shall be governed by the laws of the state of New York. To the extent permitted by other applicable law, the terms and provisions of this Agreement shall control in the event of any conflict between such terms or provisions.
