Commonly known as: 7255 Kestrel Street, Hobart, Indiana 46342.

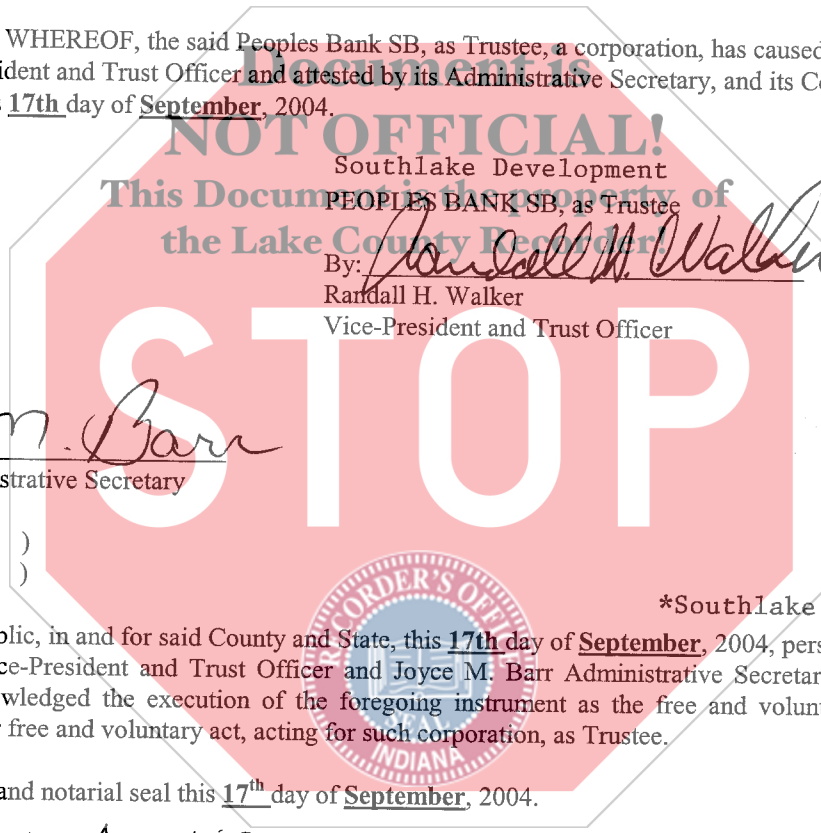
Subject to the following restrictions:

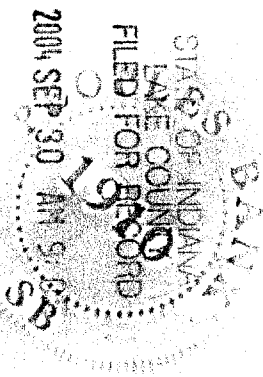

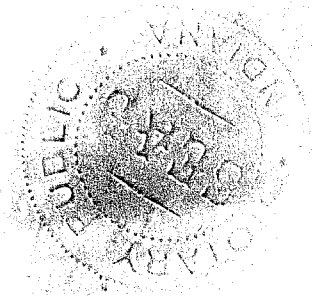
