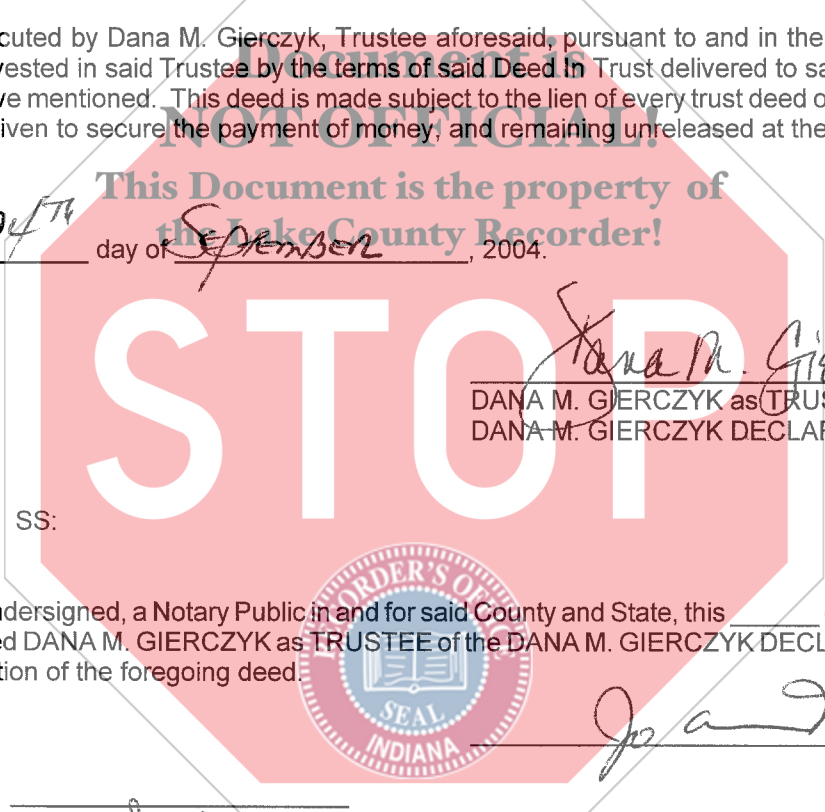
EDWARD A. GIERCZYK and DANA M. GIERCZYK, Husband and Wife

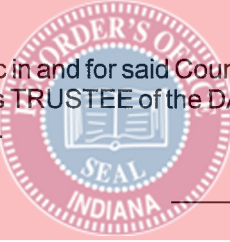

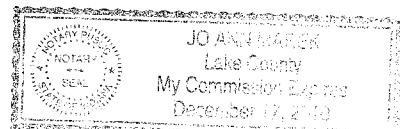
