Commonly known as: 7395 Kestrel Street, Hobart, Indiana 46342.

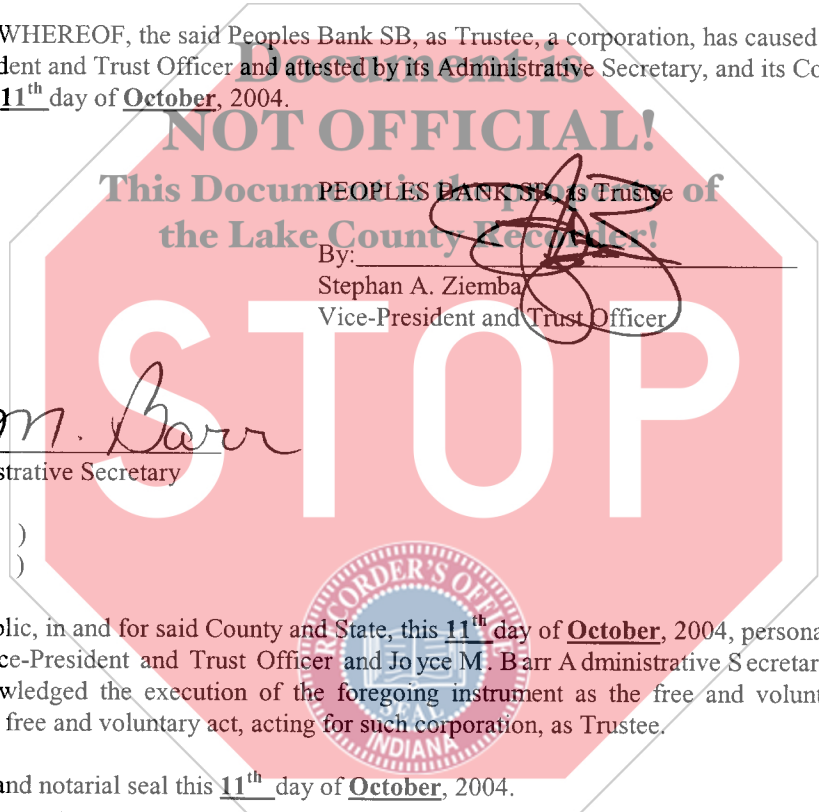
Subject to the following restrictions:
