WHEREAS, WILLIE L. JOYNER (hereinafter called "Owner") has received First-Time Home Buyers Down Payment Assistance Home Investment Partnership (HOME) Program Funds through the City's Department of Planning and Community Development First-Time Home Buyers Down Payment Assistance Program, and is the record title holder of certain property ("Property"), located in Gary, Lake County, Indiana, more particularly described as follows:

WHEREAS, pursuant to the First-Time Home Buyers Down Payment Assistance Program, the Owner must meet specified qualifications for eligibility for the Program, one of which is to comply with certain conditions and terms under the HOME Program Lien Agreement, required under the Program; and

WHEREAS, Owner has requested re-financing from Freemont Investment & Loan, P.O. Box 658, Amelia, OH 45102 (the "Lender"), and Lender desires to be in a superior position as to the Lender's interest in the Property over that of the City's interest, pursuant to the HOME Program Lien,

NOW, THEREFORE, the City does hereby consent to the SUBORDINATION of its HOME PROGRAM LIEN to the lien of Freemont Investment & Loan, its successors and/or assigns, and agrees and acknowledges that any lien, encumbrance or interest in the Property which the City may now have pursuant to the HOME Program Lien, dated December 11, 2000, and recorded as Document No. 017305 on March 9, 2001, in shall be JUNIOR AND the Office of the Recorder of Lake County, Indiana, SUBORDINATED to a security interest in the amount of Seventy Six Thousand and No/100 Dollars (\$76,000.00), plus interest, cost of collection and/or attorney's fees, which the Lender, Freemont Investment & Loan, now has or may hereafter acquire in the Property.
