

**PARTIAL RELEASE OF EASEMENT
FOR NATURAL GAS PIPELINE**

EASEMENT #8811 (Lake County)

THIS INDENTURE WITNESSETH: That NORTHERN INDIANA PUBLIC SERVICE COMPANY, an Indiana corporation, the holder of an EASEMENT FOR NATURAL GAS PIPELINE originally granted from Carl Boldt, etal, to Charles E. Hequembourg his successors and assigns, dated November 12, 1889 and recorded May 8, 1890 in Miscellaneous Record 7, page 256 and ASSIGNED TO NORTHERN INDIANA PUBLIC SERVICE COMPANY, by instrument recorded March 27, 1941 in Miscellaneous Record 329, page 98, in the Recorder's Office of Lake County, Indiana, in consideration of one dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged does hereby REMISE, RELEASE AND FOREVER QUIT CLAIM to Carl Boldt, etal, and to his successors and assigns, all the right, title and interest acquired under the aforesaid EASEMENT FOR NATURAL GAS PIPELINE in, upon, along and over that portion of the premises situated in Lake County, Indiana, described as follows:

Part of the Southwest 1/4 of the Northeast 1/4 of Section 35, Township 36 North, Range 8 West of the 2nd Principal Meridian, in the City of Hobart, Lake County, Indiana, described as follows: Beginning at the Southeast corner of the West 395.44 feet of said Northeast 1/4, said point being on the center line of 49th Avenue; thence North 89 degrees 27 minutes 42 seconds West along the South line of said Northeast 1/4 a distance of 200.00 feet; thence North 00 degrees 17 minutes 47 seconds West, parallel to the West line of said Northeast 1/4 a distance of 958.32 feet; thence South 89 degrees 27 minutes 42 seconds East, 200.00 feet; thence South 00 degrees 17 minutes 47 seconds East, 958.3 feet to the place of beginning. (Consisting of 4.4 acres, more or less)
(Taxing Unit No. 27 - Key No. 17-37-56)
