1989, upon the final account, petition to settle and allow

following, to-wit:

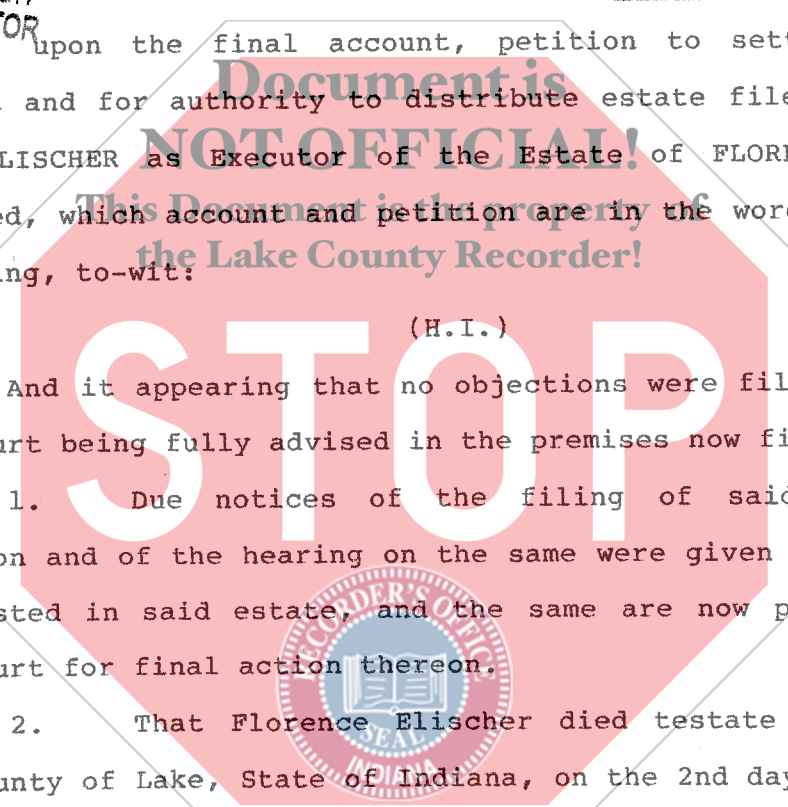

And it appearing that no objections were filed thereto and  
the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and  
petition and of the hearing on the same were given to all persons  
interested in said estate, and the same are now properly before  
the Court for final action thereon.

2. That Florence Elischer died testate a resident of  
the County of Lake, State of Indiana, on the 2nd day of May, 1989,  
and her Last Will and Testament was duly admitted to probate  
before this Court on the 17th day of May, 1989, and this Court  
appointed said Nicholas Paul Elischer as Executor of the Last Will

and Testament of the decedent, and said Executor was issued Letters of Testamentary on the 17th day of May, 1989, to him and since that date he has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said Executor has accounted for all the assets in said estate coming into his hands.

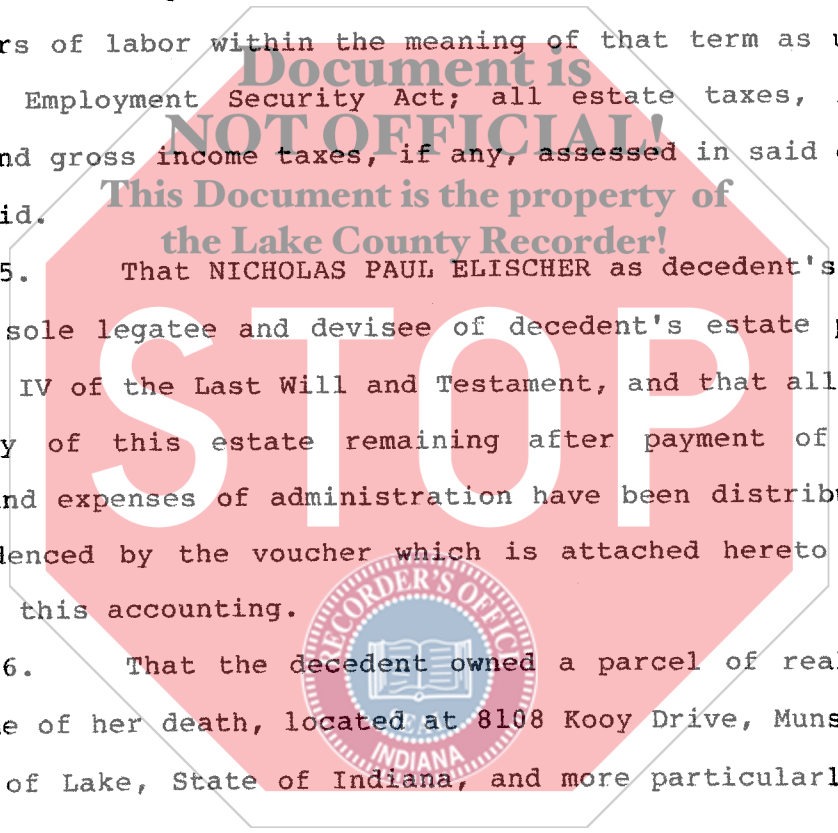
4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her Executor were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. That NICHOLAS PAUL ELISCHER as decedent's only child is the sole legatee and devisee of decedent's estate pursuant to Article IV of the Last Will and Testament, and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration have been distributed to him as evidenced by the voucher which is attached hereto and made a part of this accounting.

6. That the decedent owned a parcel of real estate at the time of her death, located at 8108 Kooy Drive, Munster, in the County of Lake, State of Indiana, and more particularly described as follows:

and that said real estate was devised to the decedent's only child, NICHOLAS PAUL ELISCHER, under Article IV of the decedent's Last Will and Testament.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Executor is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said Executor's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That the real estate at 8108 Kooy Drive, Munster, Indiana, more particularly described as follows:

Lot Two (2) in Block One (1), in Lawrence Monaldi's 3rd Addition to the Town of Munster, as per plat thereof, recorded in Plat Book 30, page 23, in the Office of the Recorder of Lake County, Indiana is now vested in NICHOLAS PAUL ELISCHER.

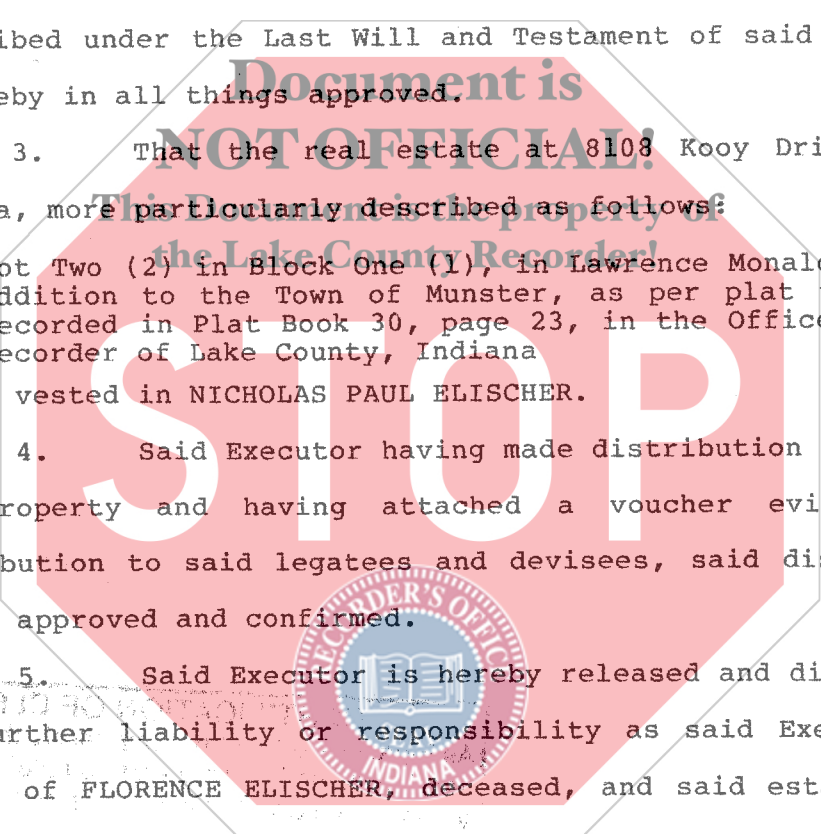
