AFFIDAVIT OF SURVIVORSHIP

2. That Gladys S. Harris and Otis E. Harris were married on the date that they acquired title as tenants by the entireties, to certain real estate by deed recorded on 7-5-63 as Document No. 491823, in the Office of the Recorder of Jasper County, Indiana, more particularly described as follows, to- Wit:

Lot Ten (10), in Block Six (6), Michigan Avenue Addition to Indiana Harbor, being a subdivision in the South one-half of Section 21, Township 37 North, Range 9 West of the Second Principal Meridian, in Lake County, Indiana.

3. That the relationship which existed between Gladys S. Harris and Otis E. Harris, continued unbroken from the time they so acquired title to said real estate until the death of Otis E. Harris on May 10, 1999 at which time Gladys S. Harris acquired title to said real estate as surviving tenant by the entirety.

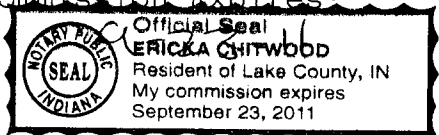
6. That the purpose of this affidavit is to induce the Lake County Auditor to show the transfer of such property on his records.
